Being a part of Quarter Township 3, Township 1, Range 6 bounded and described as follows:

Commencing at northeast corner of Branch Circle Road (Plat File 1, Page 148) at the west line of Branch Road (Plat File 1, Page 102 and 102-B); thence south 88 degrees 29 minutes 50 seconds west 237.43 feet to an iron pin; thence north 84 degrees 40 minutes 50 seconds west 2.29 feet to an iron pin; thence north 0 degrees 41 minutes 46 seconds west 14.82 feet to an iron pin found at the southwest corner of a 4.418 acre parcel conveyed to Christopher A. and Tami J. Lighthizer by deed recorded in Deed Book 1964, Page 35; thence along the south line of said 4.418 acre parcel south 89 degrees 53 minutes 46 seconds east 239.90 feet to a gin pin found at the root of a tree and being the true place of beginning of the premises herein intended to be described; thence along the east line of said 4,418 acre parcel north 0 degrees 08 minutes 14 seconds west 148.77 feet to an iron pin found; thence continuing along the east line of said 4.418 acre parcel north 25 degrees 51 minutes 46 seconds east 535.35 feet to the northeast corner of said 4.418 acre parcel; thence north 63 degrees 23 minutes 08 seconds east 1.65 feet to the west line of Branch Road as recorded in Plat File 1, Page 102 and 102-B; thence along said line of Branch Road south 25 degrees 51 minutes 46 seconds west 365.58 feet to a point; thence along said road on a curve to the left having a radius of 750.0 feet an arc length of 313.65 feet (the chord of which bears south 13 degrees 52 minutes 54 seconds west 311.37 feet) to a point; thence leaving said right of way of Branch Road north 89 degrees 53 minutes 46 seconds west 0.47 feet to the true place of beginning, containing six hundredths (0.06) of an acre more or less.
