Situated in the State of Ohio, County of Muskingum, Township of Perry.

Being a part of Quarter Township 3, Township 1, Range 6 bounded and described as follows:

Commencing at the Southwest Corner of Fractional Section 18; thence north 3 degrees 30 minutes east 1191.30 feet to a point; thence north 85 degrees 21 minutes west 1249.38 feet to a point; thence south 2 degrees 09 minutes 06 seconds west 1669.80 feet to a pin in the center of Park Lane and the true place of beginning of the premises herein intended to be described; thence south 1 degree 52 minutes 38 seconds west 971.39 feet to a stone; thence north 88 degrees 12 minutes 15 seconds west 352.95 feet to an iron pin; thence north 28 degrees 55 minutes 14 seconds west 213.68 feet to an iron pin; thence north 43 degrees 03 minutes 33 seconds east 220.64 feet to an iron pin; thence south 89 degrees 41 minutes 55 seconds east 41.84 feet to an iron pin; thence north 35 degrees 32 minutes 51 seconds east 358.61 feet to an iron pin; thence north 39 degrees 05 minutes 03 seconds west 100.69 feet to a point in the center of Park Lane; thence along said Park Lane north 42 degrees 01 minutes 27 seconds east 67.25 feet to a point; thence continuing along said Park Lane north 28 degrees 47 minutes 03 seconds east 218.95 feet to the true place of beginning, containing four and ninety-seven hundredths (4.97) acres more or less.

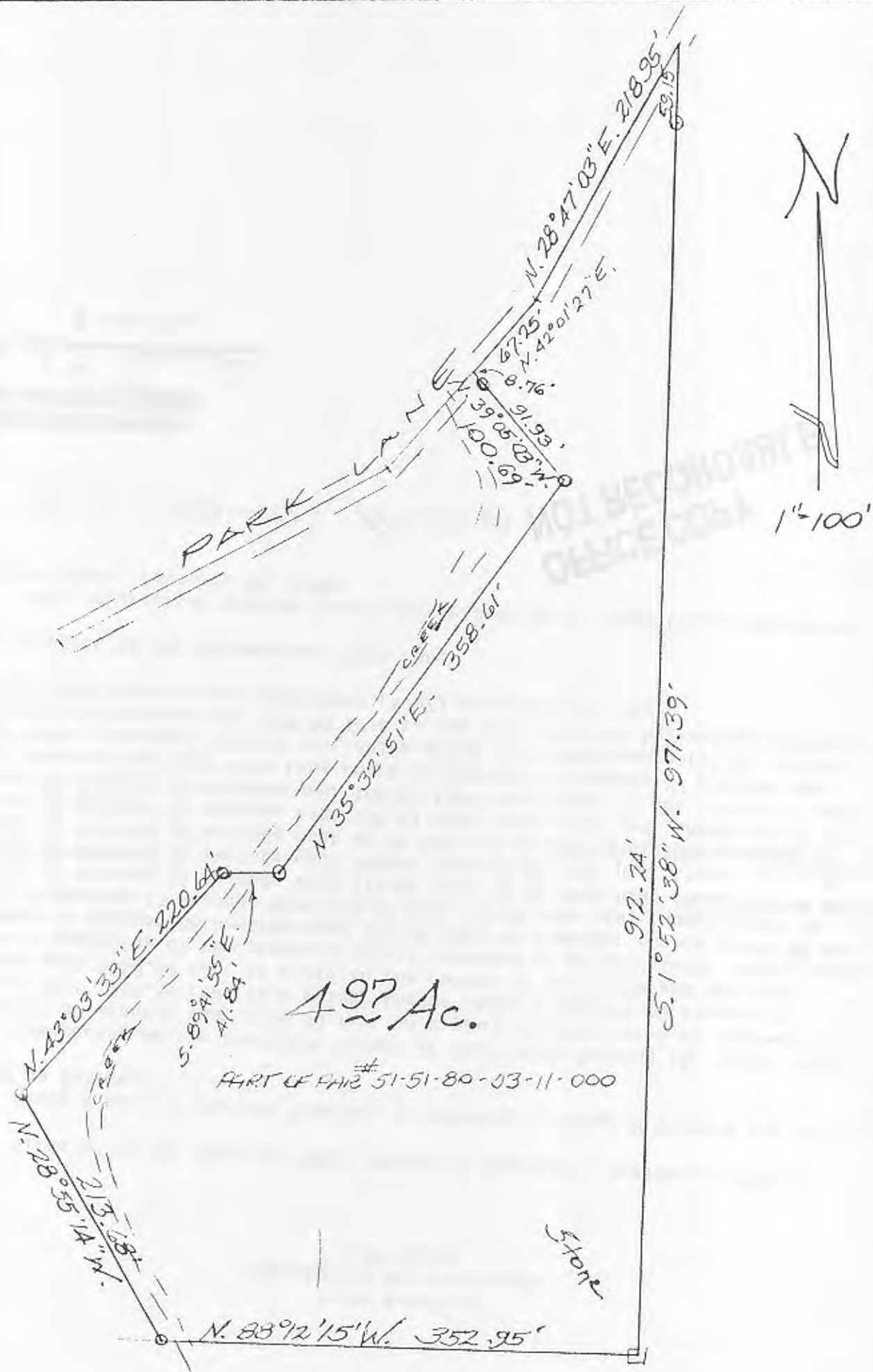
