SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF PERRY, AND BEING PART OF THE SOUTHWEST QUARTER OF SECTION 19, TOWNSHIP 1, RANGE 6, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 515, PAGE 773; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF THE SOUTHEAST QUARTER OF SECTION 19, THENCE, SOUTH 89 DEGREES - 31 MINUTES - 28 SECONDS WEST, 182.26 FEET TO A POINT; THENCE, NORTH 36 DEGREES - 01 MINUTES - 27 SECONDS WEST, 1724.23 FEET TO A POINT IN THE CENTER OF TOWNSHIP ROAD 442, PASSING AN IRON PIN SET AT 1699.23 FEET; THENCE, ALONG THE CENTERLINE OF SAID ROAD, THE FOLLOWING THREE (3) COURSES AND DISTANCES:

1) NORTH 62 DEGREES - 28 MINUTES - 44 SECONDS EAST, 59.99 FEET TO A POIMT. 2) NORTH 58 DEGREES - 10 MINUTES - 49 SECONDS EAST, 83.32 FEET TO A POINT. 3) NORTH 55 DEGREES - 28 MINUTES - 50 SECONDS EAST, 43.81 FEET TO A POINT;

THENCE, SOUTH 40 DEGREES - 13 MINUTES - 10 SECONDS EAST, 1601.34 FEET TO A POINT ON THE EAST LINE OF SAID SOUTHWEST QUARTER, PASSING AN IRON PIN SET AT 25.00 FEET; THENCE, SOUTH 00 DEGREES - 28 MINUTES - 32 SECONDS EAST, 266.73 FEET TO THE POINT OF BEGINNING, AND CONTAINING <u>9.944</u> ACRES MORE OR LESS.
