COMMENCING AT SOUTHWEST CORNER OF THE SOUTHEAST QUARTER OF SAID SECTION 19, THENCE, SOUTH 89 DEGREES - 31 MINUTES - 28 SECONDS WEST, 1359.7% FEET TO THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING SOUTH 89 DEGREES - 31 MINUTES - 28 SECONDS WEST, 790.18 FEET TO AN IRON PIN FOUND, PASSING AN IRON PIN FOUND AT 256.27 FEET; THENCE, NORTH 16 DEGREES - 12 MINUTES - 38 SECONDS WEST, 825.52 FEET TO A POINT IN THE CENTER OF TOWNSHIP ROAD 442, PASSING AN IRON PIN FOUND AT 720.52 FEET; THENCE, ALONG SAID ROAD, THE FOLLOWING THREE (3) COURSES AND DISTANCES:

- 1) NORTH 60 DEGREES 11 MINUTES 51 SECONDS EAST, 62.04 FEET TO A POINT;
- 2) NORTH 62 DEGREES 34 MINUTES 52 SECONDS EAST, 125.01 FEET TO A POINT;
