

Corrective description from a survey that was performed in 1978 and previously recorded in Deed Volume 793, Page 117 and Volume 859, Page 296.

Situated in the State of Ohio, County of Muskingum, Township of Perry, Township 1 N, Range 6 W, Quarter Township 4, Section 22, and being further described as follows;

Commencing at the northeast corner of the southwest quarter of said Section 22, thence, North 01° 10' 06" West, 35.59 feet along a quarter section line of said Section 22 to an existing iron pipe at the point of beginning of the parcel herein being described,

thence, South 49° 35' 12" West, 153.44 feet, to a point at an existing iron pipe, passing a point on the north line of the southwest quarter of Section 22,

thence, North 24° 12' 43" West, 145.58 feet to a point on the centerline of Rustic Ridge Road--Township Road 197, passing a point on the north line of the southwest quarter of said Section 22 at 74.36 feet, also passing a point at an existing iron pipe at 122.75 feet,

thence, North 36° 27' 41" East, 121.04 feet along the centerline of said Rustic Ridge Road to a point,

thence, South 38° 41' 03" East, 167.36 feet to the point of beginning, passing an iron pin (set in 1978) at 16.14 feet,

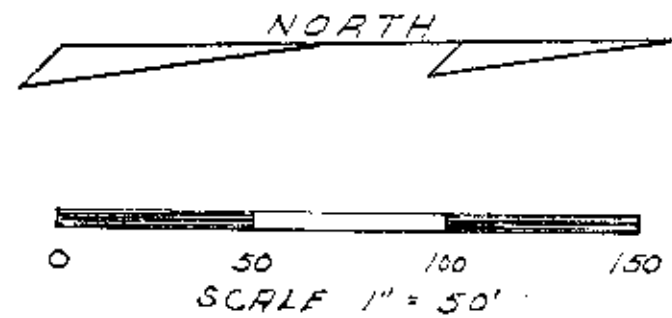
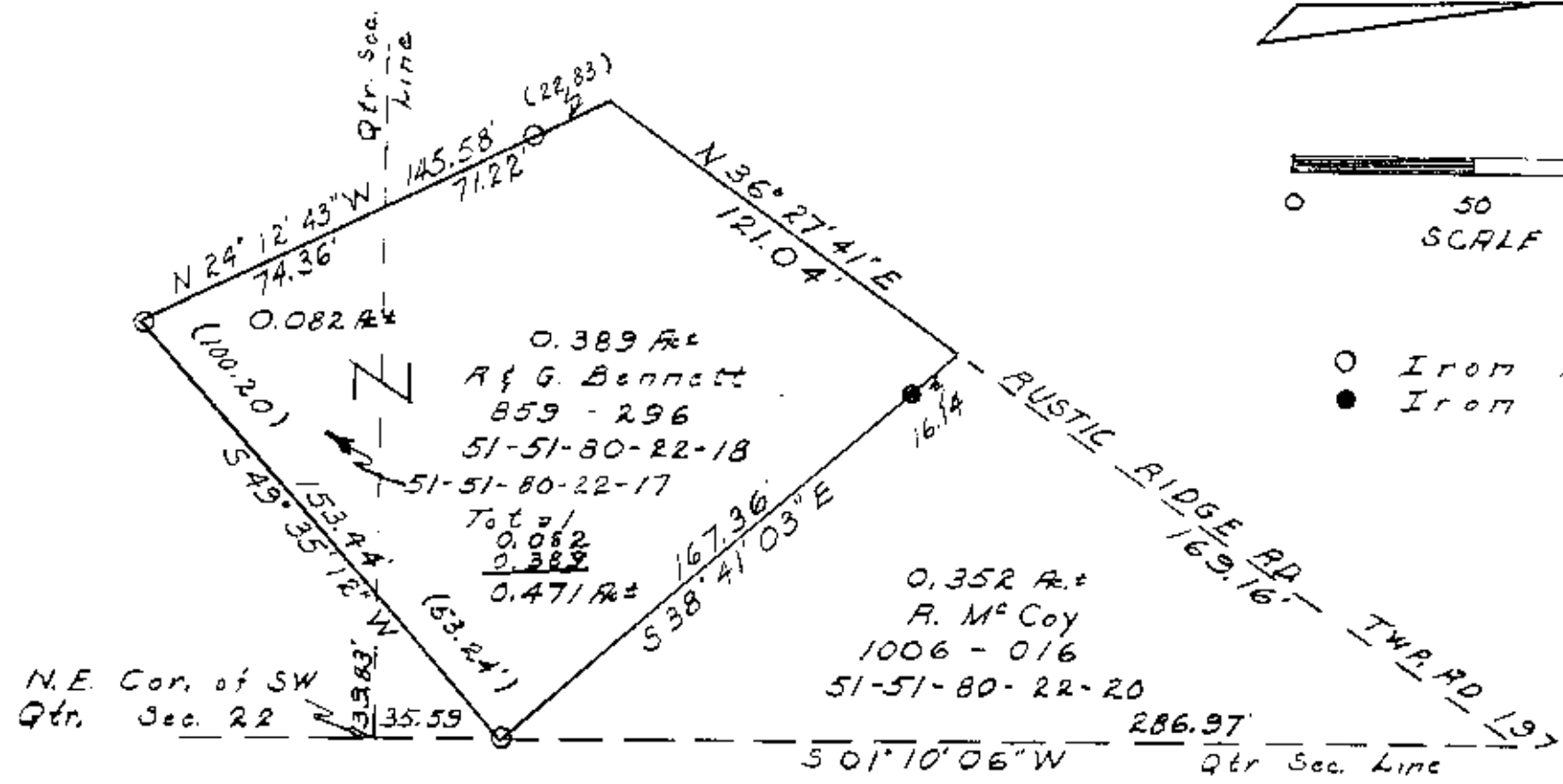
