- North 75 degrees 35 minutes 29 seconds West, 455.98 feet to an iron pin found just pass the west side of said road bed and being on the common line of said Cramer and Donald R. & Anna L. McCoy's lands;

- 2. North 58 degrees 00 minutes 59 seconds East, 476.84 feet to a point on said section line, said point is referenced by an iron pin set that bears South 61 degrees 34 minutes 18 seconds East, 27.58 feet:

thence leaving the southeast quarter of Section 23 crossing back over into Section 22, North 58 degrees 00 minutes 59 seconds East, 266.80 feet to a point on the mid-section line of Section 22, said point is referenced by an iron pin set that bears South 13 degrees 37 minutes 22 seconds East, 47.66 feet;

thence with said mid-section line, South 88 degrees 12 minutes 07 seconds East, 1741.97 feet to an iron pin found on the south line of the lands now owned by Randy L. & Pamela I. Pyle (DR 1129-116), also being the northwest corner of the lands now owned by Jeremy & Crystal Marie Brokaw (OR 1976-450), passing iron pins found at 328.83 feet (referenced by an iron pin found that bears North 02 degrees 05 minutes 17 seconds East, 59.50 feet) and 737.06 feet;

thence with the common line of said Cramer and Brokaw the following two (2) courses:


