Thence South 12 degrees 30 minutes 17 seconds East 121,75 feet to an iron pipe found on the southwest corner of Zemba Farms (DR 1141-547) and northeast corner of D & K Brock (DR 1123-251);

Thence South 74 degrees 15 minutes 10 seconds West 216.51 feet to an iron pin found on the northeast corner of D & K Brock (DR 1123-251) and the northwest corner of D & D Roberts (DR 1127-267);

Thence along the north property line of D & D Roberts (DR 1127-267) the following 3 courses:

North 71 degrees 46 minutes 04 seconds West 241.50 feet to an iron pin found; North 68 degrees 53 minutes 44 seconds West 180.42 feet to an iron pin found;

North 81 degrees 28 minutes 15 seconds West 105,83 feet to an iron pin found on the southeast corner of Gibson (DR 1158-483);

Thence leaving said north property line North 19 degrees 06 minutes 18 seconds. West 329.35 feet to the principle place of beginning, containing 8.56 acres, more or less.

Iron pins found are 5/8 inch rebar with identification caps (BIEDENBACH PS5718-PS6923).


