**LEGAL DESCRIPTION FOR THE
BARNA PROPERTY**

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF RICH HILL, AND BEING THE NORTHWEST QUARTER OF SECTION 5 AND PART OF THE NORTHEAST QUARTER OF SECTION 5, TOWNSHIP 13, RANGE 11 AS RECORDED IN DEED VOLUME 516, PAGE 240 AND VOLUME 650, PAGE 279; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN FOUND AT THE NORTHWEST CORNER OF THE NORTHWEST QUARTER OF SAID SECTION 5, THENCE, ALONG THE NORTH LINE OF SECTION 5, SOUTH 89 DEGREES - 50 MINUTES - 34 SECONDS EAST, 1649.87 FEET TO A POINT, PASSING AN IRON PIN FOUND AT 1594.09 FEET;

THENCE, CONTINUING ALONG THE NORTH LINE OF SAID SECTION, SOUTH 89 DEGREES - 51 MINUTES - 09 SECONDS EAST, 1250.67 FEET TO A POINT IN THE CENTER OF COUNTY ROAD #368 (WILSON PLACE), PASSING IRON PINS SET AT 1001.15 FEET AND 1234.84 FEET;

THENCE, ALONG THE CENTERLINE OF SAID ROAD, THE FOLLOWING TWELVE (12) COURSES AND DISTANCES:

1) SOUTH 10 DEGREES - 03 MINUTES - 31 SECONDS WEST, 62.57 FEET TO A POINT;

2) SOUTH 16 DEGREES - 17 MINUTES - 22 SECONDS WEST, 247.43 FEET TO A POINT;

3) SOUTH 18 DEGREES - 08 MINUTES - 25 SECONDS WEST, 325.64 FEET TO A POINT;

4) SOUTH 16 DEGREES - 22 MINUTES - 04 SECONDS WEST, 74.84 FEET TO A POINT;

5) SOUTH 10 DEGREES - 40 MINUTES - 36 SECONDS WEST, 44.14 FEET TO A POINT;

6) SOUTH 05 DEGREES - 33 MINUTES - 55 SECONDS WEST, 47.51 FEET TO A POINT;

7) SOUTH 00 DEGREES - 12 MINUTES - 47 SECONDS EAST, 54.54 FEET TO A POINT;

8) SOUTH 03 DEGREES - 34 MINUTES - 35 SECONDS EAST, 228.58 FEET TO A POINT;

9) SOUTH 00 DEGREES - 26 MINUTES - 26 SECONDS EAST, 136.17 FEET TO A POINT;

10) SOUTH 01 DEGREES - 30 MINUTES - 55 SECONDS WEST, 158.70 FEET TO A POINT;

11) SOUTH 00 DEGREES - 50 MINUTES - 30 SECONDS WEST, 157.91 FEET TO A POINT;

12) SOUTH 01 DEGREES - 45 MINUTES - 16 SECONDS EAST, 259.55 FEET TO A POINT;

THENCE, LEAVING SAID ROAD, NORTH 88 DEGREES - 41 MINUTES - 23 SECONDS EAST, 358.38 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 30.00 FEET;

THENCE, SOUTH 19 DEGREES - 18 MINUTES - 37 SECONDS EAST, 159.06 FEET TO AN IRON PIN SET;

THENCE, SOUTH 54 DEGREES - 18 MINUTES - 37 SECONDS EAST, 215.82 FEET TO AN IRON PIN SET;

THENCE, SOUTH 22 DEGREES - 18 MINUTES - 37 SECONDS EAST, 347.82 FEET TO AN IRON PIN SET;

THENCE, SOUTH 04 DEGREES - 41 MINUTES - 23 SECONDS WEST, 286.64 FEET TO A POINT ON THE SOUTH LINE OF THE NORTHEAST QUARTER OF SECTION 5;

THENCE, SOUTH 89 DEGREES - 52 MINUTES - 56 SECONDS WEST, 3404.38 FEET TO AN IRON PIN FOUND AT THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF SECTION 5, PASSING AN IRON PIN SET AT 22.51 FEET, ALSO PASSING AN IRON PIN SET AT THE SOUTHEAST CORNER OF THE NORTHWEST QUARTER OF SECTION 5 AT 749.89 FEET;

THENCE, NORTH 00 DEGREES - 10 MINUTES - 00 SECONDS EAST, 2655.87 FEET ALONG THE WEST LINE OF SECTION 5 TO THE POINT OF BEGINNING, AND CONTAINING A TOTAL OF 178.2004 ACRES MORE OR LESS, OF WHICH --

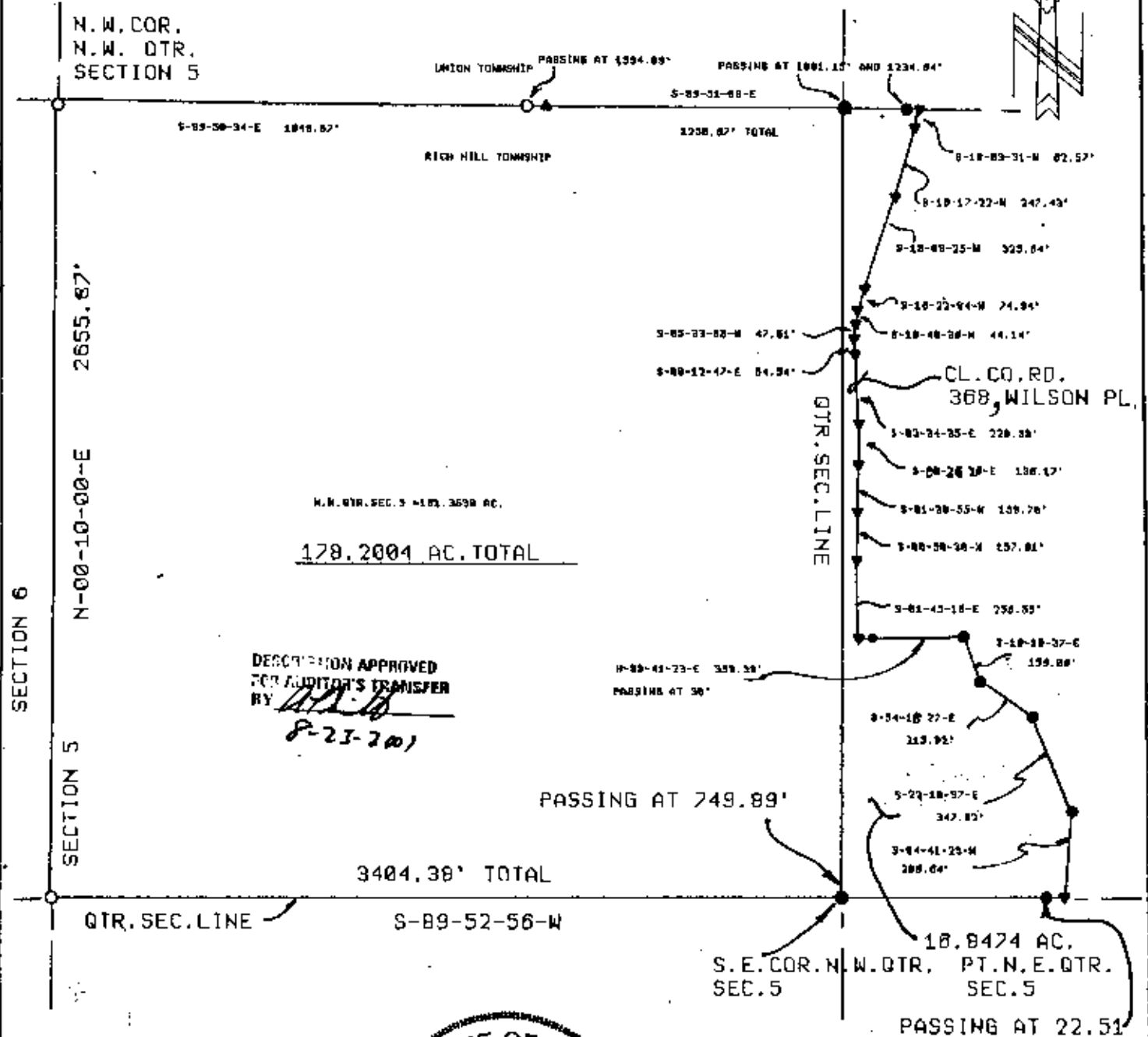
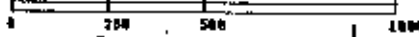

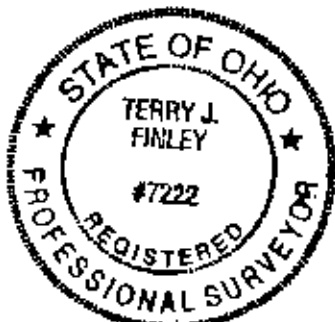
