Situated in the State of Ohio, County of Muskingum, Township of Rich Hill:

Being a part of the Southwest Quarter and the Northwest Quarter of Section Six (6), Township Thirteen (13), Range Eleven (11) of the Congress Lands East of the Scioto River and part of property now owned by Jeffrey and Cathie Kreager and Recorded in Deed Book 942, Page 279 of the Muskingum County Deed Records bounded and described as follows:

Beginning at an iron pin set in Tom Road at the northeast corner of the southwest quarter of section 6; thence S 2° 34' 55" W (the base of bearings for this description is State Plane Grid from a solar observation) along the east line of said southwest quarter and along the west line of property owned by Robert E. and Marjorie McKee (Vol. 540, pg. 692) a distance of 342.25 feet to an iron pin set in the east side of said Tom Road, said pin bears S 37° 05' 48" E 44.45 feet from an iron pin set; thence S 82° 08' 52" W along the north line of a 3.998 acre parcel owned by Jeffrey and Cathie Kreager (Vol. 880, pg. 253) a distance of 420.95 feet to a railroad spike set in a drive, said spike bears S 24° 43' 44" W 16.05 feet from an iron pin set and passing through an iron pin set at the northwest corner of said 3.998 parcel at 221.24 feet; thence N 10° 36' 32" W 411.60 feet to an iron pin set; thence N 78° 50' 49" E 522.87 feet to a railroad spike set in Tom Road on the half section line and passing from the southwest quarter into the northwest quarter at 63.69 feet and through a fence post at 145.27 feet and through an iron pin set at 496.96 feet; thence S 2° 34' 55" W along the east line of said northwest quarter of section 6 a distance of 106.39 feet to the place of beginning containing Four and Six-hundred-two-thousandths (4.602) acres.

0.545 of an acre is in the northwest quarter of section 6 and is part of Auditors Parcel No. 53-01-06-06-000.

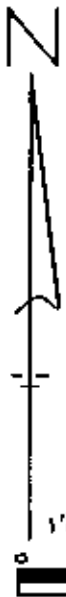
4.057 acres is in the southwest quarter of section 6 and is part of Auditors Parcel No. 53-01-06-08-000.

BASE OF BEARINGS IS STATE PLANE GRID FROM A SOLAR OBSERVATION

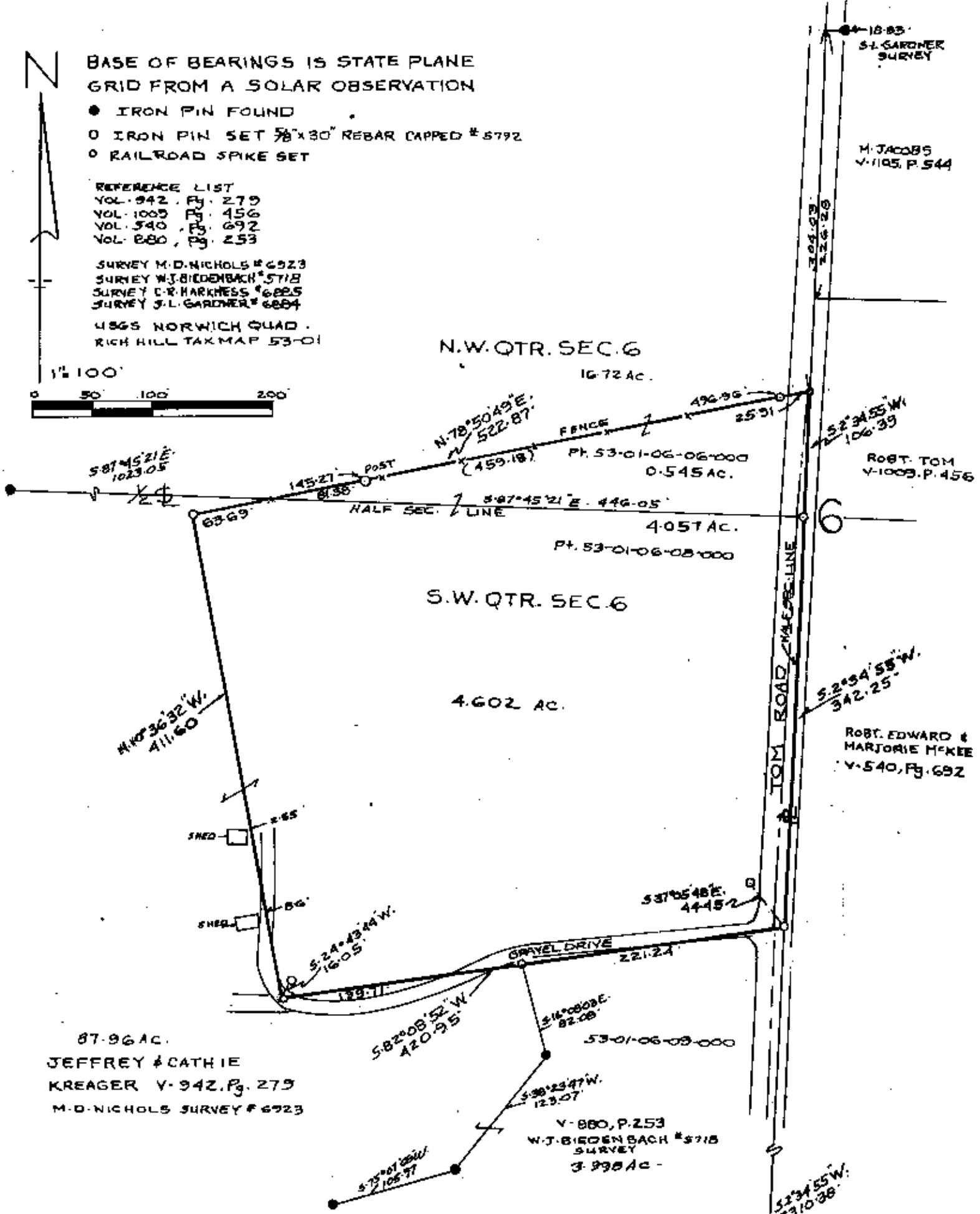
