Legal Description for Part of Tract 21;Parcel Six;"MR-98"

A certain tract of land situated in the State of Ohio, Muskingum County, Rich Hill Township, and being a part of the west one-half of the southeast quarter of Section 9, Township 13 North, Range 11 West, and being more particularly bounded and described as follows:

BEGINNING at a corner common to the lands now or formerly owned by Marva M. Washington (O.R.V. 1935, Pg. 819), and the lands now or formerly owned by Richard W. Caton, Jr., (O.R.V. 2127, Pg. 665; Parcel No. 5), and being in the line of the lands now owned by AEP Generation Resources Inc., (O. R. V. 2551, Pg. 487; Tract 21, Parcel Six), being in the centerline of Ohio State Route No. 313, at the intersection of the north-south mid-section line of Section 3, T. 13 N., R.11 W., and being located at centerline station 9+59.93, as shown on Sheet No. 3, for Project No. MUS-313-4.11, having a coordinate value of N. 695,268.973 and E. 2,176,542.557; thence, leaving the said north-south mid-section line, and the lands of the said Washington and the lands of the said Caton, Jr., and severing the lands of the said AEP Generation Resources Inc., with the centerline of the said State Route No. 313, as follows:

North 81° 06' 08" East 40.07 feet to PC station 10+00; thence, with a curve to the left, having a radius of 572.96 feet, and an arc length of 209.17 feet, the long chord of which bears:

North 70° 38' 38" East 208.01 feet to PT station 12+09.17; thence,

North 60° 11' 08" East 10.11 feet to PC station 12+19.28; thence, with a curve to the left, having a radius of 572.96 feet, and an arc length of 141.00 feet, the long chord of which bears:

North 53° 08' 08" East 140.64 feet to PT station 13+60.28; thence,

North 46° 05' 08" East 365.97 feet to centerline station 17+26.25; thence, leaving the centerline of the said Route No. 313, continuing to sever the lands of the said AEP Generation Resources Inc.

South 04° 19' 36" West, passing a 5/8" reinforcing rod with a red plastic cap stamped "Eastham & Associates" (set), 30.00 feet right of and at right angle to centerline station 16+92.65, at 45.05 feet, in all 1,128.39 feet to a 5/8" reinforcing rod (found) with a yellow plastic cap stamped "Gardner PS-6884" (found), marking a corner common to the lands now or formerly owned by The Trustees of Rich Hill Cemetery (D.V. 1052, Pgs. 277 and 280), from which a second 5/8" reinforcing rod (found) with a yellow plastic cap stamped "Gardner PS-6884" (found), bears: South 01° 48' 32" East 92.35 feet; thence, with lands of the said Cemetery Trustees,

North 88° 06' 11" West, passing a third 5/8" reinforcing rod (found) with a yellow plastic cap stamped "Gardner PS-6884" (found), at 216.32 feet, and crossing County Road No. 448, commonly known as Herron Road, in all 257.74 feet to a 5/8" reinforcing rod with a red plastic cap stamped "Eastham & Associates" (set), in the line of the lands now or formerly owned by Terry L. Billy, et ux, (D.V. 1133, Pg. 285); thence, leaving the lands of the said Cemetery Trustees, and with the lands of the said Billy, et ux,

North 09° 31' 51" West 42.48 feet to a 5/8" reinforcing rod (found) with a yellow plastic cap stamped "P.J. Boeshart PLS 6512" (found) beside the said Road No. 448, marking a corner common to the lands now or formerly owned by Donald C. Oliver, et ux, (D.V. 1113, Pg. 515); thence, leaving the lands of the said Billy, et ux, and with the lands of the said Oliver, et ux, as follows:

North 09° 23' 24" West 270.11 feet to a "Cotton Gin Spindle" (set), in the said Road No. 448,

North 27° 23' 24" West 132.00 feet to a 5/8" reinforcing rod with a red plastic cap stamped "Eastham & Associates" (set), beside the said Road No. 448,

North 53° 08' 24" West 85.80 feet to a 5/8" reinforcing rod with a red plastic cap stamped "Eastham & Associates" (set),

North 87° 28' 57" West 8.19 feet to a 5/8" reinforcing rod with a red plastic cap stamped "Eastham & Associates" (set),

North 02° 31' 03" East 198.00 feet to a 5/8" reinforcing rod (found) with a yellow plastic cap stamped "P.J. Boeshart PLS 6512" (found), near the intersection of the said County Road No. 448, with the said State Route No. 313,

North 87° 28' 57" West 99.00 feet to a 5/8" reinforcing rod (found) with a yellow plastic cap stamped "P.J. Boeshart PLS 6512" (found), on the said north-south midsection line and being in the line of the lands of the said Washington; thence, leaving the lands of the said Oliver, et ux, and with the said north-south mid-section line, and the lands of the said Washington,

North 02° 31' 03" East 18.72 feet to the BEGINNING, containing 8.232 acres, more or less, as surveyed under the direct supervision of Ronald L. Eastham, Ohio Registered Surveyor No. 6026, and being a part of Tract MR-98, as shown on the attached plat and made a part of this description.
