thence along the south line of Lot 22 North 87 degrees 53 minutes 34 seconds West for a distance of 436.93 feet to the centerline of State Route 313 and the principal place of beginning;

thence along the centerline of said State Route 313 the following three courses:

- 1) South 49 degrees 41 minutes 08 seconds West for a distance of 51.64 feet to a point;
- 2) along a curve to the right having a radius of 812.70 feet and an arc length of 582.64 feet, being subtended by a chord bearing South 79 degrees 03 minutes 45 seconds West for a distance of 570.24 feet to point;
- 3) North 80 degrees 23 minutes 58 seconds West for a distance of 42.04 feet to a point;

thence North 40 degrees 40 minutes 19 seconds West for a distance of 215.36 feet to a point on the south line of lands now owned by Ohio Power Company (DR 289-794), passing an iron pin set at 39.12 feet;

thence along said Ohio Power Company's south line South 87 degrees 53 minutes 34 seconds East for a distance of 781.59 feet to the principal place of beginning;

containing 2.15 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.

Iron pins set are 5/8 inch diameter by 30 inch long rebar with plastic identification caps.

Bearings are based on NAD 93, Ohio State Plane Coordinate System, South Zone, Grid North, as per GPS observations of Muskingum County GPS Monuments.


