

## DESCRIPTION OF SURVEY FOR DAN HUELSMAN TRACT #1

Situated in the State of Ohio, County of Muskingum, Township of Rich Hill, Worthwest Quarter, of Section #18, Township #13, Range #11, of the Congress Lands East of the Scioto River:

Being all of the First and Second Parcels of the prior deed reference Volume 774, Page 289 of said county's deed records, also being all of Muskingum County Auditor's Parcel Mumbers 53-53-40-18-04-000 (covering said First Parcel), 53-53-40-18-05-000 (covering said Second Parcel) and more particularly described as follows;

Beginning at a wood post (found) at the Northwest corner of said Section #18;

#1thence along the North line of said Section #18 S 87 11 23 E 1312.85 feet to an iron pin (set by previous survey at the common corner with the F White property as described in deed reference Volume 488, Page 688;

thence along the Western lines of said White property as previously surveyed by Charles R. Harkness RS #6885 completed on 7/18/1989 the following six courses

- #9~ 528.00 feet to an iron pin (set) on the South line of said Northwest Quarter of Section #18;
- #10- thence along the South line of said Northwest Quarter R 87 11 23 W 817.85 feet to a stone (found) at the Southwest corner of said Northwest Quarter;
- #11- thence along the West line of said Northwest Quarter N 02 53 09 E 2685.87 feet to the place of beginning containing 9.425 acres covering said First Parcel and 50.428 acres covering said Second Parcel for a total of 59.853 acres.

The bearings within this description are based on a True North Solar Observation (Local Hour Angle Method) completed by Charles R. Harkness RS #6885 on 7/18/89 as part of a survey of the F. White property described in deed reference Volume 488, Page 688. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).
