## DESCRIPTION OF SURVEY FOR BRIAN MATTOX

Situated in the State of Obio, County of Muskingun, Township of Rich Hill:

Being part of the Morthwest and Southwest Quarters, of Section #20, Township #13. Range #11, of the Congress Lands East of the Scioto River, being part of the prior deed reference Volume 495, Page 265 of said county's deed records, also being part of Muskingun County Auditor's Parcel Number 53-53-40-20-13-000 in said Worthwest Quarter, part of Parcel Number 53-53-40-20-18-000 in said Southwest Quarter and more particularly described as follows:

Commencing at the Center of said Section #20 as described by deed and recorded in deed reference Volume 914, Page 17; thence N 87 20 59 W 2073.28 feet (by deed) along the Quarter Section line between said Northwest and Southwest Quarters to the East line of the Brain Mattox property as described in said Volume 914, Page 17, from which an iron pin (found) at the Southeast corner of said Mattox property for reference bears S 00 33 17 E 330.15 feet; thence N 00 33 17 W 302.67 Feet along the East line of said Mattox property to the Northeast corner of said Mattox property, passing an iron pin (found) at 260.11 feet, said Wortheast corner also being in the center of Township Road #208 (Leedom Road), and the place of beginning for the property herein intended to be described;

- #1- thence S 39 44 57 W 470.31 feet along the center of said road, passing into said Southwest Quarter:
- #2- thence \$ 36 39 25 W 49.86 feet continuing along said road to the Northeast corner of the T. Tom property as described in deed reference Volume 764, Page 51;
- #3- thence N 77 01 46 W 267.58 feet along the North line of said Tom property to an iron pin (found) on the West line of said Section #20, passing an iron pin (set) at 21.73 feet;
- #4- thence N 02 46 52 E 700.32 feet along the West line of said Section #20 to an iron pin (set) on the West line of said Northwest Quarter, from which an iron pin (re-set from a survey completed by L. Peter Dinan RS #5451 on September 24, 1980) at the Southwest corner of the R Clark property as described in deed reference Volume 516, Page 726, for reference hears N 02 46 52 E 142.64 feet
- #5- thence \$ 63 05 55 E 677.36 feet through said prior deed reference Volume 577, Page 265, to the center of said road, passing an iron pin (set) at 654.86 feet:
- #6- thence S 42 16 05 W 69.57 feet continuing through said prior deed reference and along the center of said road to the place of beginning containing 5.899 acres in said Northwest Quarter and 0.652 acres in said Southwest Quarter for a total of 6.551 acres.
