LEGAL DESCRIPTION FOR MILDRED WARNE

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF RICH HILL, AND BEING PART OF THE SOUTHEAST QUARTER OF SECTION 20, TOWNSHIP 13, RANGE 11, AND BEING ALL THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1044, PAGE 83. FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER OF THE SOUTHEAST QUARTER OF SECTION 20, THENCE, SOUTH 00 DEGREES - 26 MINUTES - 05 SECONDS WEST, 2042.69 FEET TO AN IRON PIN FOUND AT THE SOUTHEAST CORNER OF THOSE LANDS DESCRIBED IN DEED VOLUME 1019, PAGE 159, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED: THENCE, SOUTH 00 DEGREES - 26 MINUTES - 05 SECONDS WEST, 641.23 FEET TO A POINT ON THE WEST LINE OF LANDS RECORDED IN DEED VOLUME 936, PAGE 131; THENCE, NORTH 89 DEGREES - 41 MINUTES - 03 SECONDS WEST, 2223.06 FEET ALONG THE NORTH LINE OF LANDS DESCRIBED IN DEED VOLUME 943, PAGE 79 TO AN IRON PIN FOUND IN THE CENTER OF COUNTY ROAD #63 (HIGH PREELAND RD.), PASSING AN IRON PIN FOUND AT 469.19 FEET AND A STONE FOUND AT 1253.87 PEET: THENCE, ALONG THE CENTER OF SAID COUNTY ROAD, THE FOLLOWING EIGHT COURSES AND DISTANCES:

THENCE, NORTH 89 DEGREES - 01 MINUTES - 07 SECONDS EAST, 50.76 FEET TO AN IRON PIN POUND; THENCE, NORTH 88 DEGREES - 52 MINUTES - 21 SECONDS EAST, 1092.96 FEET TO A POST; THENCE, SOUTH 89 DEGREES - 46 MINUTES - 22 SECONDS EAST, 132.00 FEET TO A 15" OAK TREE; THENCE, SOUTH 77 DEGREES - 03 MINUTES - 10 SECONDS EAST, 303.77 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 89 DEGREES - 35 MINUTES - 12 SECONDS EAST, 673.83 FEET TO THE POINT OF BEGINNING, AND CONTAINING 35.16 ACRES MORE OR LESS.
