DESCRIPTION OF SURVEY FOR GLENN KENNEDY

Situated in the State of Ohio, County of Muskingum, Township of Rich Hill:

Being part of the Northwest Quarter, of Section #31, Township #13, Range #11, of the Congress Lands East of the Scioto River, **being part of** the Glenn Kennedy property described in deed reference Official Record Volume 1565, Page 418 of said county's deed records, known as Muskingum County **Auditor's Parcel Number 53-70-31-07-000**, and more particularly described as follows;

Commencing at an iron pin (set) at the Northwest corner of said Section #31, also being the common corner for Section #30 of said Township and Range, and for Sections #25 & #36 of Township #13, Range #12 in Salt Creek Township; THENCE **South 87 degrees 12 minutes 20 seconds East 711.92 feet** along the common line for said Sections #30 & #31 to an iron pin (set) at a common corner for said Kennedy property and for the M Janicki property recorded in deed reference Deed Book Volume 1052, Page 109, also being the place of beginning of the property herein intended to be described;

- #1- THENCE South 87 degrees 12 minutes 20 seconds East 459.45 feet continuing along the common line for said Sections #30 & #31 to an iron pin (set);
- #2- THENCE South 22 degrees 52 minutes 40 seconds West 623.71 feet into said Section #31 and through said Kennedy property to the center line of Big Muskie Drive (State Route #284), passing an iron pin (set) at 593.71 feet;
- #3- THENCE North 59 degrees 07 minutes 20 seconds West 68.31 feet along the center of said road and continuing through said Kennedy property to an unmarked point;
- #4- THENCE North 57 degrees 33 minutes 50 seconds West 103.06 feet continuing along said road and through said Kennedy property to an unmarked point;
- #5- THENCE North 57 degrees 46 minutes 10 seconds West 141.90 feet continuing along said road and through said Kennedy property to an unmarked point from which an iron pin (set) for reference bears South 18 degrees 51 minutes 40 seconds West 26.41 feet;
- #6- THENCE North 57 degrees 46 minutes 00 seconds West 123.27 feet continuing along said road and through said Kennedy property to the Southeast corner of said Janicki property;
- #7- THENCE North 22 degrees 47 minutes 40 seconds East 396.21 feet leaving said road and along a common line for said Kennedy and Janicki properties to the place of beginning, passing an iron pin (set) at 30.00 feet, containing 5.05 acres.

The bearings within this description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
