Sarbaugh, Trustee, (OR 2459-86), South 01 degrees 45 minutes 02 seconds West, 190.21 feet to a point in the centerline of Symmes Creek Road, (Twp. Rd. 168), and the principal place of beginning, passing an iron pin set at 167.96 feet;

Thence continuing along the section line, and the west line of said Sarbaugh lands, South 01 degrees 45 minutes 02 seconds West, 1178.20 feet to an iron pin set at a fence corner, passing an iron pin set at 20.03 feet;

Thence through the lands presently owned by William S. and Jean E. Bush, (DR 1148-327), the following four courses:

- 1.) South 88 degrees 55 minutes 04 seconds West, 232.76 feet to an iron pin set at a fence corner;
- 2.) North 78 degrees 06 minutes 08 seconds West, 326.92 feet to an iron pin set at a fence corner;
- 3.) North 14 degrees 48 minutes 21 seconds East, 20.80 feet to an iron pin set at a fence corner;
- 4.) North 73 degrees 41 minutes 03 seconds West, 299.54 to a point in the centerline of Symmes Creek Road, (Twp. Rd. 168), passing an iron pin set at 279.21 feet;

Thence along the centerline of said road the following seven courses:

- 1.) North 23 degrees 36 minutes 35 seconds East, 260.51 feet to a point;
- 2.) North 25 degrees 51 minutes 30 seconds East, 266.06 feet to a point;
- 3.) North 27 degrees 20 minutes 54 seconds East, 259.83 feet to a point;
- 4.) North 40 degrees 18 minutes 46 seconds East, 199.20 feet to a point;
- 5.) North 66 degrees 19 minutes 52 seconds East, 153.88 feet to a point;
- 6.) North 76 degrees 32 minutes 48 seconds East, 135.46 feet to a point;
- 7.) North 66 degrees 30 minutes 20 seconds East, 141.19 feet to the principal place of beginning, containing 15.668 acres, more or less, and being part of Auditor's Parcel Number 56-01-04-01-000.
