

DESCRIPTION FOR CONVEYANCE
UNICE EMERSON

Being a part of the southwest quarter of Section 5, Salem Township, Muskingum County, Ohio, Township 2, Range 6 of the United States Military District, being more particularly described as follows:

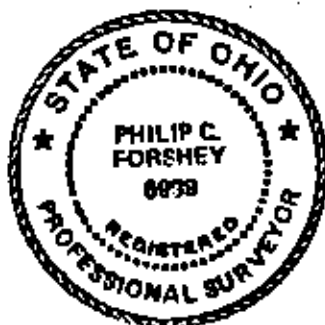
Beginning at the northeast corner of the southwest quarter of aforementioned Section 5; thence, along the mid-section line S 0°00'09" W, 1126.35' to a point in the centerline of Mollies Rock Road; thence, along the centerline of said road the next three courses: N 74°36'59" W, 181.19', N 80°06'28" W, 109.64', N 88°05'27" W, 117.73' to the true place of beginning of the parcel of land intended to be described: thence leaving said centerline, S 0°03'21" W, 588.05', along the west line of a tract in the name of Tom Emerson to an iron pin (found) having passed through an iron pin at 30.0'; thence, N 89°59'51" W, 377.07' to an iron pin set; thence N 0°03'24" E, 567.15' to a point in the centerline of Mollies Rock Road, having passed through an iron pin at 537.15'; thence, along the centerline of said road the following two courses: N 86°44'38" E, 114.43', N 86°51'58" E, 263.22' to the point of beginning containing 5.001 acres more or less subject to all legal easements and rights of way.

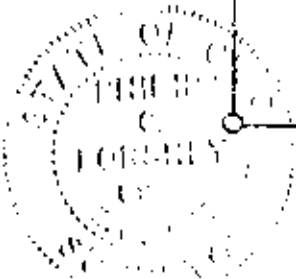
