BEING A PART OF A TRACT CONVEYED TO ROGER D. AND RITA M. BAKER RECORDED IN DEED BOOK VOLUME 812, PAGE 286 OF THE MUSKINGUM COUNTY DEED RECORDS; SITUATED IN LOT NUMBER 25 OF THE FIRST QUARTER OF TOWNSHIP 2, RANGE 6, OF THE UNITED STATES MILITARY LANDS, SALEM TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:





