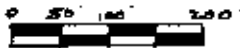
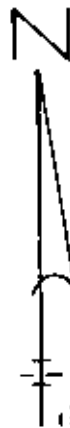

- STONE FOUND

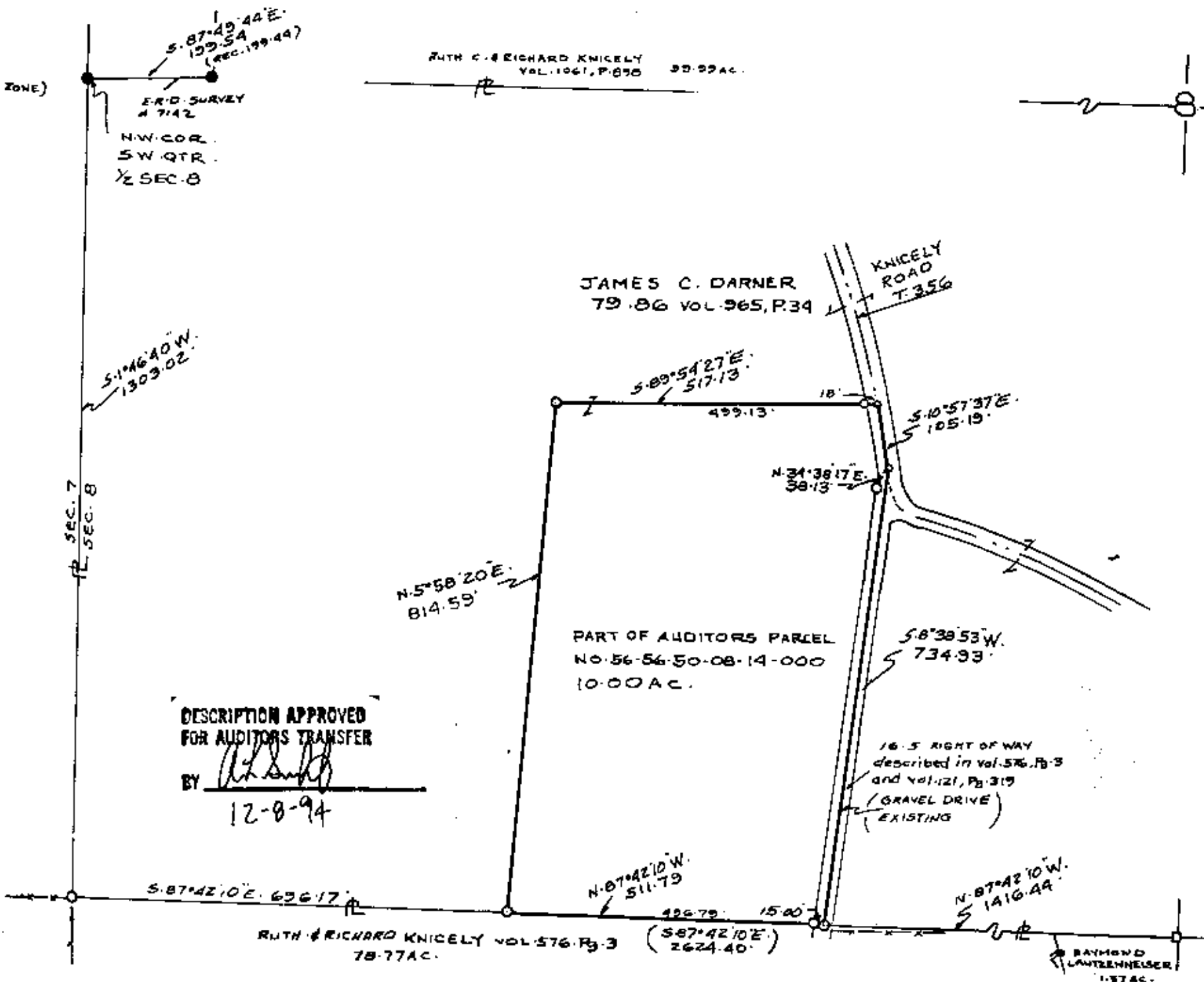
