

DESCRIPTION OF SURVEY FOR RONALD WHITE

JOB#946-3

Situated in the State of Ohio, County of Muskingum, Township of Salem:

Being part of the Southeast Quarter, of Section #16, Township #2, Range #6, of the US Military District, **being part of the Ronald White** property described in deed reference Deed Book Volume 812, Page 24 of said county's deed records, known as Muskingum County Auditor's Parcel Number 56-70-16-29-000, and more particularly described as follows;

Commencing at the Southwest corner of the Southeast Quarter of Section #16, also being the Northwest corner of the Northeast Quarter of Section #25 of said Township and Range, and being in the roadbed of Tucker Road (Township Road #111); **thence N 90 00 00 E 1281.31 feet** along the common line for Sections 16 and 25 and within said roadbed to the place of beginning for the property herein intended to be described;

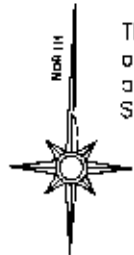
- #1- **thence N 04 59 50 E 452.26 feet** leaving said roadbed, into Section #16, and through said White property to an iron pin (set), passing an iron pin (set) at 23.09 feet;
- #2- **thence N 04 55 50 E 437.15 feet** continuing through said White property to an iron pin (set);
- #3- **thence N 58 37 30 W 80.48 feet** continuing through said White property to an iron pin (set);
- #4- **thence N 78 23 50 W 175.80 feet** continuing through said White property to an iron pin (set);
- #5- **thence N 02 38 10 E 472.27 feet** continuing through said White property to an iron pin (set);
- #6- **thence S 60 48 40 E 1271.09 feet** continuing through said White property to an iron pin (set);
- #7- **thence S 17 31 40 W 238.06 feet** continuing through said White property to an iron pin (set);
- #8- **thence S 10 35 50 E 207.15 feet** continuing through said White property to an iron pin (set);
- #9- **thence S 05 09 30 E 386.13 feet** continuing through said White property and along the East line of a 20 foot wide easement saved and excepted from the property herein described, to the common line for Sections #16 and #25 being in the roadbed of said Tucker Road, passing an iron pin (set) at 358.97 feet;
- #10- **thence N 90 00 00 W 968.56 feet** along the common line for Sections #16 and #25 and within said roadbed to the place of beginning **containing 24.295 acres.**

The bearings within the description are based on an assumed bearing of East along the South line of the Southeast Quarter of Section #16. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

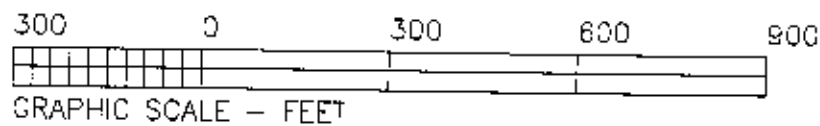

A survey completed by Richard Daniels PLS #5410 on January 19, 1986 of the Ronald White property recorded in Deed Book Volume 1004, Page 494. A survey completed by Richard Cannon PLS #5489 of the D Brooks property recorded in Deed Book Volume 1012, Page 28. Green Acres Subdivision recorded in Plat Book 12, Page 55.

Note #1- The Southwest corner of the Southeast Quarter of Section #16 was established using monumentation found in Green Acres Subdivision with parole and field evidence. The corner is near the center of the existing roadbed.

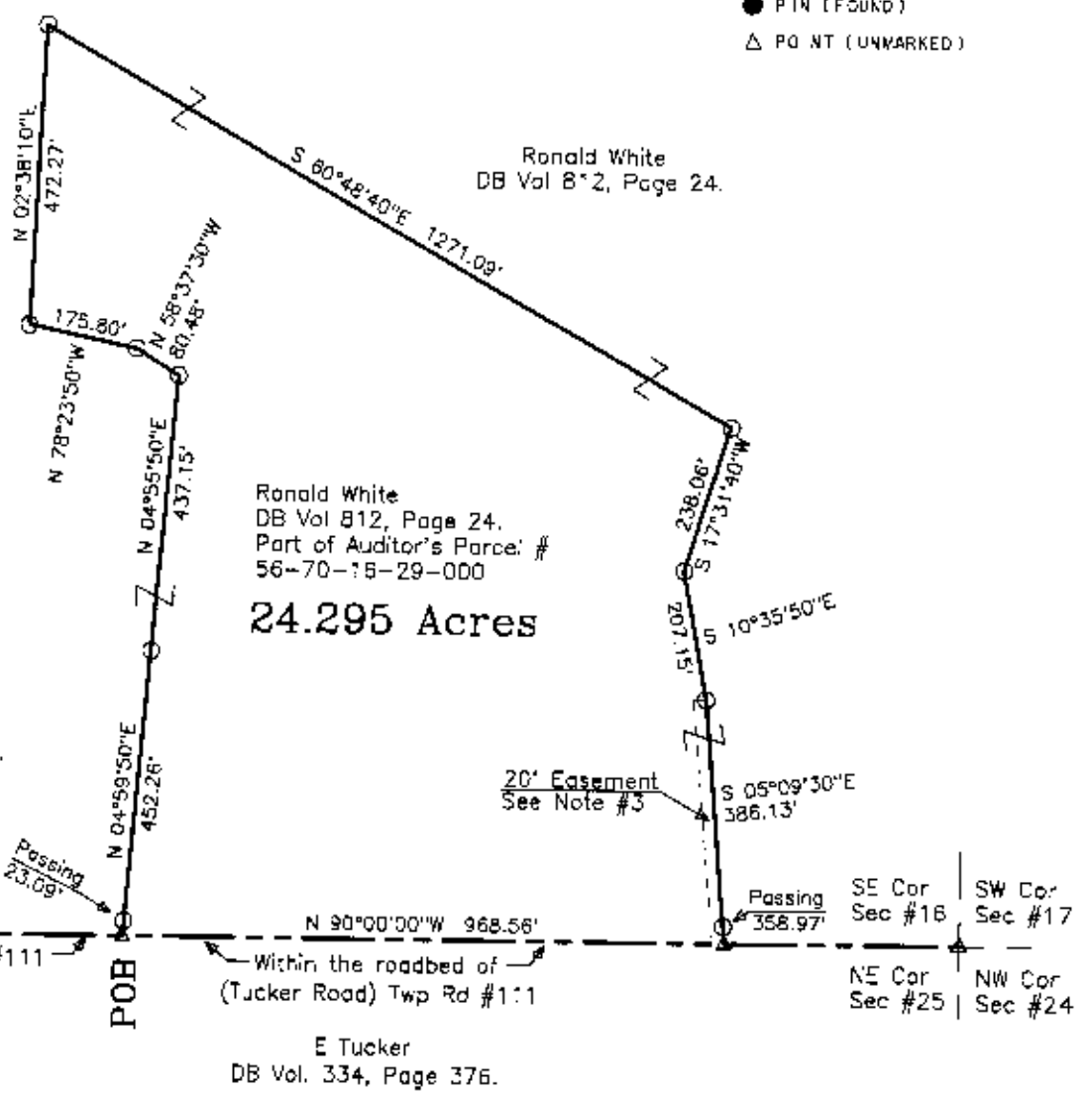
Note #2- The Southeast corner of Section #16 was established using monumentation found for the Ronald White and D Brooks properties located in the Southwest Quarter of Section #17. The surveys for each are listed.

Note #3- A 20 foot wide easement is being saved and excepted from the 24.295 acre parcel.
