DEED DESCRIPTION

Being a part of the Northwest Quarter of Section 18 and a part of the Southwest Quarter of Section 18, both in Township 2, Range 6, Salem Township, Muskingum County, Ohio (also being a survey of the property of Bruce H. Knipe described in Deed Book 827, page 336 of the Muskingum County Recorder) and being more particularly described as follows:

Beginning, at an existing stone, marking the Southwest corner of the Northwest Quarter of Section 18; thence N 0°29' 27" E 1064.43 feet, in the West line of Section 18, to a railroad spike set in County Road 183 (said railroad spike is in the Easterly edge of pavement of County Road 183 and is presently a gravel surface), passing iron pins set at 203.65 feet, 297.26 feet and 518.04 feet; thence, leaving the West line of Section 18 and County Road 183, \$ 89°17' 30" E 1065.40 feet to a railroad spike set in the center of Township Road 82 (said railroad spike bears N 89'17' 30" W from a reference iron pin found), passing an iron pin set at 53.65 feet; thence, the following 21 (twenty-one) courses are to railroad spikes set in the center of Township Road 82, S 59 19 49" E 22.55 feet; thence \$ 49'09' 53" E 25.81 feet; thence \$ 36'42' 04" E 38.21 feet; thence S 29°50' 40" E 174.89 feet (survey by W.J. Biedenbach P.S. #5718 reads S 29°56' 13" E 174.86 feet on this course); thence S 43°41' 21" E 78.74 feet; thence S 59°58' 31" E 41.67 feet; thence S 69°58' 49" E 68.28 feet; thence S 74°21' 45" E 95.53 feet; thence S 60°57' 37" E 89.45 feet; thence S 33°55' 56" E 41.51 feet; thence S 11 26' 23" E 62.68 feet; thence S 1 52' 54" W 113.46 feet; thence S 5'22' 06" E 152.39 feet; thence S 10'35' 14" E 92.27 feet; thence S 16"42' 53" E 100.94 feet; thence S 22'48' 52" E 101.85 feet; thence S 25°47' 32" E 50.70 feet, passing through the mid line of Section 18 at 31.02 feet; thence S 31° 10' 52" E 89.78 feet; thence S 42° 39' 50" E 82.61 feet; thence S 50°26' 42" E 96.84 feet; thence S 18°20' 18" E 30.97 feet (said railroad spike bears N 86°29' 29" W 30.65 feet from a reference iron pin found and N 86°29' 29" W 229.53 feet from a reference iron pin found); thence, leaving Township Road 82, N 86 29' 29" W 159.87 feet to the center of a white oak (24 inches in diameter), passing an iron pin set at 149.25 feet; thence S 36°21' 40" W 726.01 feet, along an old fence, to an iron pin set; thence N 89°37' 06" W 1305.58 feet, along an old fence, to an existing stone in the West line of Section 18;

thence N 0°29' 27" E 812.54 feet, in the West line of Section 18, to the place of beginning. The tract as surveyed contains 65.630 acre, more or less, subject to all legal highways and easements of record.
