BEING A PART OF TRACTS CONVEYED TO LEE GUNNELS BY DEED RECORDED IN VOLUME 1137, PAGE 104 OF THE MUSKINGUM COUNTY DEED RECORDS; SITUATED IN THE SOUTHWEST QUARTER OF SECTION 18 AND THE NORTHWEST QUARTER OF SECTION 23, TOWNSHIP 2, RANGE 6, OF THE UNITED STATES MILITARY LANDS, SALEM TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

**BEGINNING AT AN EXISTING STONE AT THE SOUTHEAST CORNER OF THE SOUTHWEST QUARTER OF SECTION 18;**

**THENCE SOUTH 03 DEGREES 31 MINUTES 41 SECONDS EAST ALONG THE EAST LINE OF THE NORTHWEST QUARTER OF SECTION 23, 31.67 FEET TO A POINT IN COUNTY ROAD 64 (NORFIELD ROAD);**

**THENCE WITH THE CENTER OF SAID ROAD THE NEXT TWO COURSES AND DISTANCES:**

- 1) SOUTH 59 DEGREES 21 MINUTES 35 SECONDS WEST 260.65 FEET TO A POINT;
- 2) SOUTH 53 DEGREES 33 MINUTES 36 SECONDS WEST 182.57 FEET TO A POINT AT THE INTERSECTION OF THE CENTERLINE OF TOWNSHIP ROAD #2 (KNIPE ROAD);

**THENCE WITH THE CENTER OF SAID KNIPE ROAD THE NEXT TWO COURSES AND DISTANCES:**

- 1) NORTH 39 DEGREES 40 MINUTES 39 SECONDS WEST 245.50 FEET TO A POINT IN THE CENTER OF SAID ROAD;
- 2) NORTH 45 DEGREES 55 MINUTES 02 SECONDS WEST 50.56 FEET TO A POINT IN THE CENTER OF SAID ROAD;

**THENCE LEAVING THE SAID KNIPE ROAD AND TRAVERSING THROUGH THE ABOVE SAID GUNNELS TRACT (VOLUME 1137, PAGE 104), NORTH 24 DEGREES 58 MINUTES 55 SECONDS EAST 711.67 FEET TO AN IRON PIN SET, PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 19.47 FEET AND AN IRON PIN SET AT 309.61 FEET;**

**THENCE WITH THE SOUTH LINE OF A TRACT CONVEYED TO JOHN TRESMOTT (VOLUME 1051, PAGE 631), NORTH 88 DEGREES 04 MINUTES 47 SECONDS EAST 224.58 FEET TO A POINT ON THE EAST LINE OF THE SOUTHWEST QUARTER OF SECTION 18, SAID POINT BEING SOUTH 88 DEGREES 04 MINUTES 47 SECONDS WEST 0.44 FEET FROM AN EXISTING IRON PIN (5/8 INCH REBAR);**

**THENCE WITH THE SAID EAST LINE OF THE SOUTHWEST QUARTER, SOUTH 03 DEGREES 31 MINUTES 41 SECONDS EAST 604.99 FEET TO THE PLACE OF BEGINNING.**

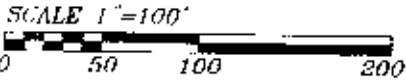
