

Survey Split of Gary M. and Cynthia A. Heil, Parcel 2, Salem Township, Muskingum County

Situated in the State of Ohio, County of Muskingum, Township of Salem, and being part of the Southeast Quarter of Section 18, Township 2, Range 6, United States Military Lands, and being part of the lands presently owned by Gary M. and Cynthia A. Heil, as per Official Record 2581, Page 590, and being more particularly described as follows:

Beginning for reference, at a railroad spike found, at the southeast corner of the Southeast Quarter of Section 18, Township 2, Range 6, United States Military Lands;

Thence along the section line and in Norfield Road, (Co. Rd. 64, R\W 40'), North 88 degrees 07 minutes 52 seconds West, 602.99 feet to a point and the principal place of beginning;

Thence continuing along the section line and in said road, North 88 degrees 07 minutes 52 seconds West 75.67 feet to a point in the centerline of said road;

Thence along the centerline of said road the following three courses:

- 1.) Along a non-tangent curve to the right, with a delta angle of 25 degrees 31 minutes 29 seconds, a radius 388.36 feet, an arc length of 173.01 feet, and a chord which bears North 66 degrees 26 minutes 12 seconds West, 171.58 feet to a point;
- 2.) Along a non-tangent curve to the left, with a delta angle of 5 degrees 50 minutes 22 seconds, a radius of 2510.45 feet, an arc length of 255.86 feet, and a chord which bears North 58 degrees 48 minutes 59 seconds West, 255.75 feet to a point;
- 3.) Along a non-tangent curve to the left, with a delta angle of 5 degrees 08 minutes 00 seconds, a radius of 447.60 feet, an arc length of 40.10 feet, and a chord which bears North 63 degrees 43 minutes 44 seconds West, 40.09 feet to a point;

Thence through the lands presently owned by Gary M. and Cynthia A. Heil, (OR 2581-590), the following three courses:

- 1.) North 41 degrees 18 minutes 34 seconds East, 700.88 feet to an iron pin set, passing an iron pin set at 28.48 feet;
- 2.) South 72 degrees 48 minutes 48 seconds East, 232.43 feet to an iron pin set, being on the west line of Parcel 1;
- 3.) South 16 degrees 11 minutes 04 seconds West, 707.04 feet to the principal place of beginning, passing an iron pin found at 687.83 feet, and containing 6.26 acres, more or less, and being part of Auditor's Parcel Number 56-80-18-12-000;

Subject to all legal recorded easements and right of ways.

Iron pins set are 5/8 inch rebars, 30 inches long, with plastic identification caps.

Bearings are based on the Ohio State Plane Coordinate System, NAD 83, South Zone, Grid North, as per G.P.S. observations.
