Situate in the State of Ohio, County of Muskingum, Township of Salem, Township 2, Range 6, part of the Northwest Quarter of Section 21, bounded and described as follows:

**Parcel One:**

Being the split of Elmer F. and D. Darlene Lentz Property Vol. 952, Page 226. Parcel No. 56-56-90-21-10-000.

Commencing at the Southeast Corner of the Northwest Quarter of Section 21; Thence North 8°27'44" East 897.60 feet to a point; Thence North 81°32'16" West 1033.80 feet to an iron pin set the place of beginning; Thence North 81°32'16" West 206.86 feet to a point in County Road 440 passing an iron pin set at 186.86 feet; Thence in County Road 440 North 5°31'04" East 181.24 feet to a point; Thence leaving said road North 78°26'09" East 201.86 feet to an iron pin set passing an iron pin set at 15.72 feet; Thence South 5°31'00" East 252.52 feet to the place of beginning containing 1.00 acres more or less;

Bearings are based on the West line of the Northwest Quarter of Section 21 bearing North 8°27'44" East.

Commencing at the Southeast Corner of the Northwest Quarter of Section 21; Thence North 8°27'44" East 897.60 feet to a point; Thence North 81°32'16" West 1033.80 feet to an iron pin; Thence North 5°31'05" West 252.52 feet to an iron pin set the place of beginning; Thence South 78°26'09" West along Parcel One 201.86 feet to County Road 440 passing an iron pin set at 186.14 feet; Thence North 5°31'04" West 218.71 feet to a point in County Road 440, 218.71 feet to a point; Thence leaving County Road 440 South 81°32'16" East 206.86 feet to an iron pin found passing an iron pin set at 20.00 feet; Thence South 5°31'05" East 147.48 feet to the place of beginning containing 0.84 acres more or less;

Bearings are based on the East line of the Northwest Quarter of Section 21 bearing North 8°27'44" East.

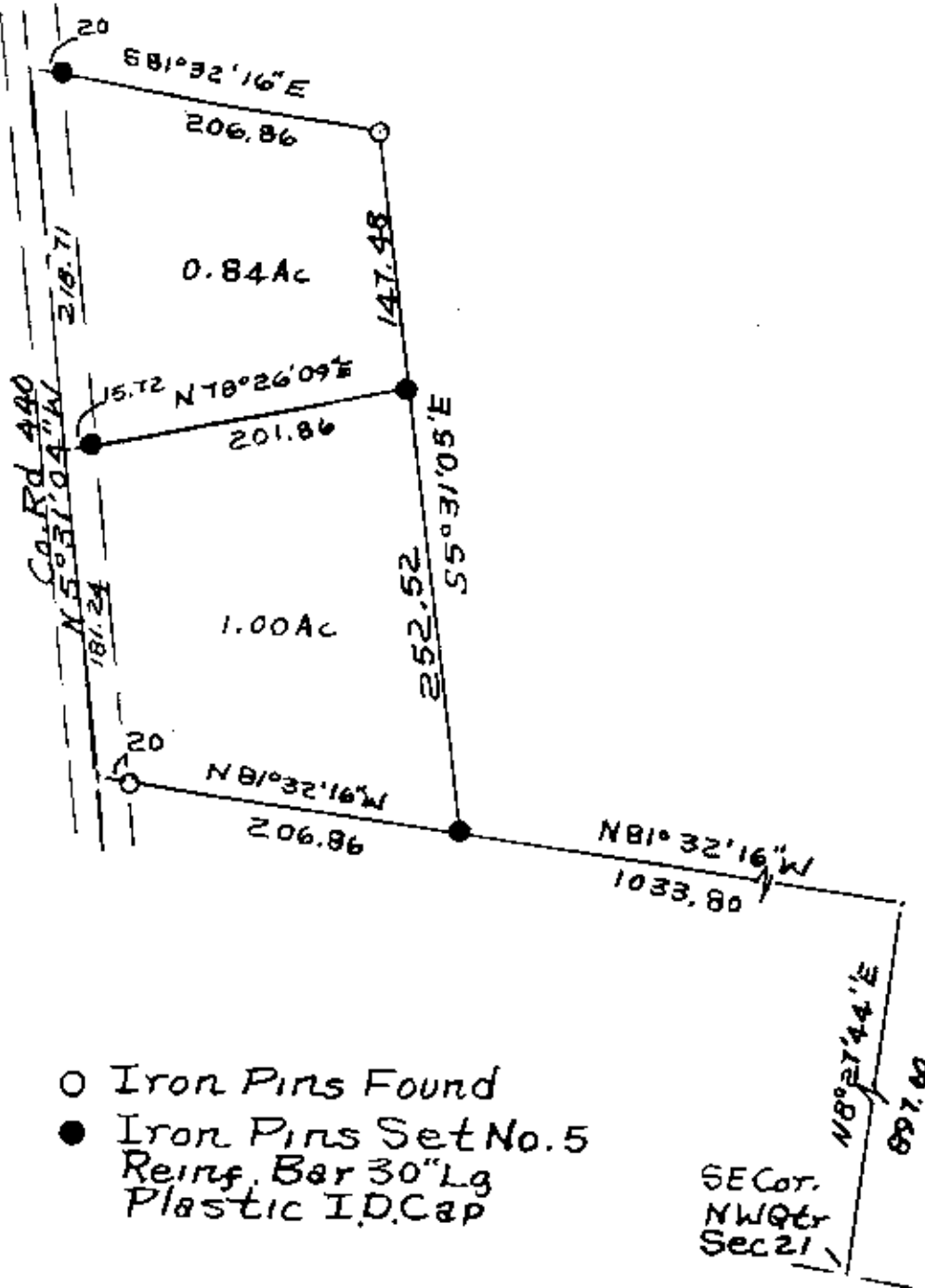
