

**Chris Pidcock**

Situated in the State of Ohio, County of Muskingum, Township of Salem, Township 2, Range 6, part of the Southwest Quarter of Section 21, bounded and described as follows:

Part of Chris Pidcock Property Deed Vol. 877, Page 143, Parcel No. 56-56-90-21-17-000.

Commencing at the Southwest Corner of the Southwest Quarter of Section 21; Thence South  $88^{\circ}00'00''$  East 2215.22 feet to a point; Thence North  $2^{\circ}40'32''$  East 475.82 feet to a point in center of Arch Hill Road the place of beginning; Thence along the split lines of Chris Pidcock Vol. 877, Page 143 the next 4 courses and distances leaving said<sup>1/4</sup> North  $81^{\circ}24'00''$  West 311.50 feet to an iron pin set passing an iron pin set at 20.00 feet; Thence North  $20^{\circ}30'48''$  East 317.97 feet to an iron pin set; Thence North  $69^{\circ}22'49''$  East 238.77 feet to a point in center of Arch Hill Road passing an iron pin set at 213.77 feet; Thence along center of Arch Hill Road South  $3^{\circ}35'34''$  West 429.32 feet to the place of beginning containing 2.19 acres more or less;

Excepting a 20.00 foot wide right of way easement along the North side from Arch Hill Road.

Bearing are based on the South line of the Southwest Quarter of Section 21 bearing South  $88^{\circ}00'00''$  East.

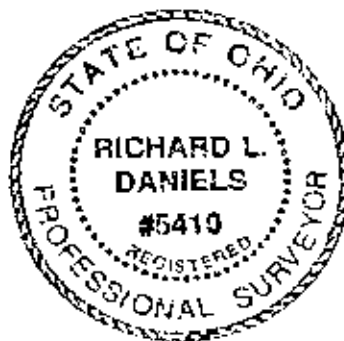

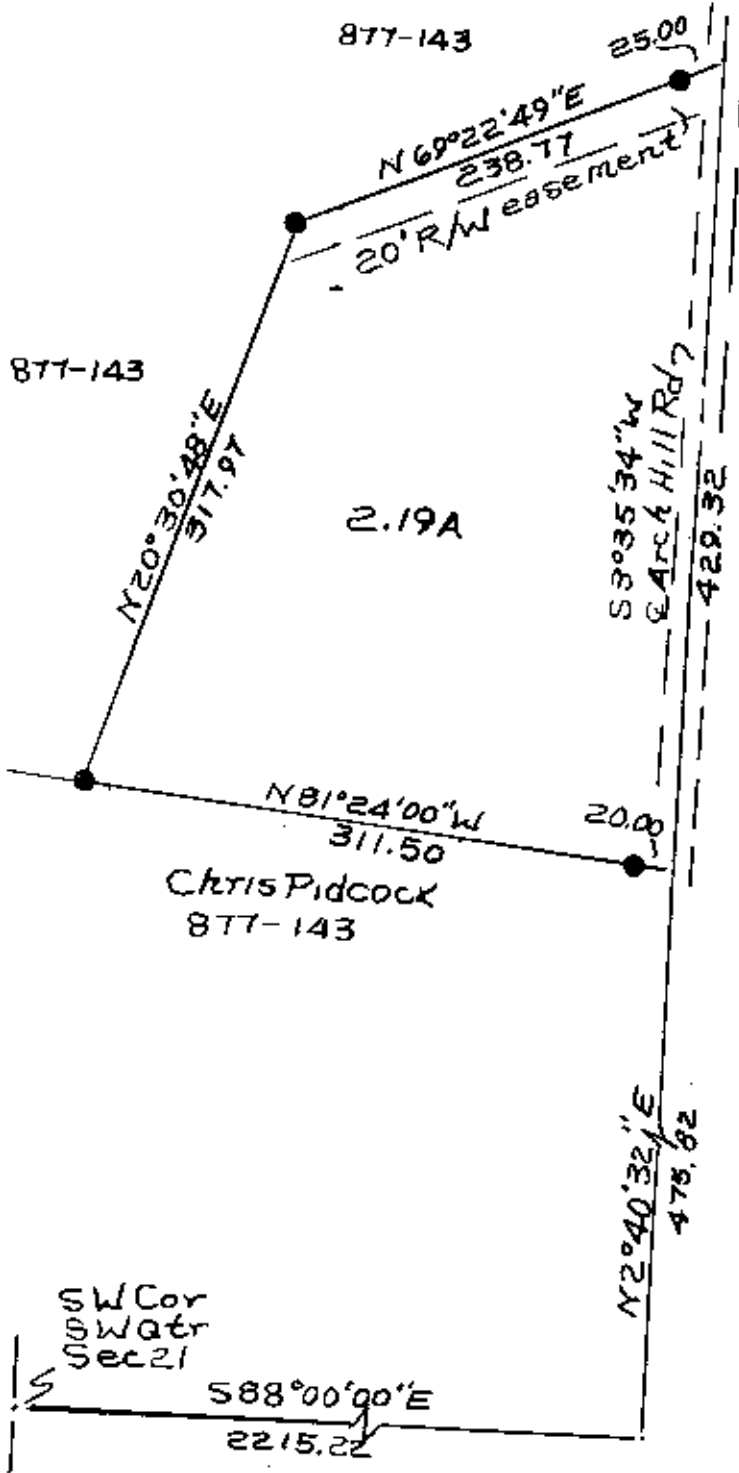
Iron pins set are No. 5 reinf. bars 30 inches long with plastic ID caps.
