Thence North 84 degrees 17 minutes 03 seconds East along the centerline of Cronin Lane and the south line of said 6.68-acre Cronin tract for a distance of 189.03 feet to the **TRUE POINT OF BEGINNING** for the herein described tract, said point being referenced by a 3/4" iron pipe found South 00 degrees 33 minutes 29 West at a distance of 15.00 feet;

Thence, continuing along the centerline of Cronin Lane and said 6.68-acre Cronin tract south line the following courses:

South 79 degrees 18 minutes 26 seconds East for a distance of 70.33 feet to a point;
South 58 degrees 33 minutes 09 seconds East for a distance of 166.99 feet to a point;
South 39 degrees 29 minutes 19 seconds East for a distance of 136.03 feet to the southeast corner of said 6.68-acre Cronin tract, referenced by a 5/8" rebar (Dinan-5451 cap) found North 40 degrees 29 minutes 23 seconds East at a distance of 30.0 feet;

Thence, continuing along the centerline of Cronin Lane and along a new line of division through the above referenced 31.19-acre Cronin tract the following courses:

South 46 degrees 25 minutes 12 seconds East for a distance of 177.92 feet to a point;
South 42 degrees 34 minutes 31 seconds East for a distance of 217.97 feet to a point;
South 43 degrees 59 minutes 36 seconds East for a distance of 138.21 feet to a point of curvature:

Thence along a curve to the left having a radius of 140.00 feet, a delta angle of 43 degrees 16 minutes 20 seconds, a chord bearing and distance of South 65 degrees 37 minutes 46 seconds East, 103.24 feet, along an arc length of 105.73 feet to a point;

**South 87 degrees 15 minutes 56 seconds East** for a distance **92.03 feet** to a MAG spike set on the east line of the 31.19-acre Cronin tract, being the west line of a 76.712-acre tract conveyed to Joseph A. Gormley III and Christi A Gormley, Deed Book 2829 Page 939;

Thence, South 00 degrees 00 minutes 00 seconds East, leaving Cronin Lane and along the east line of said 31.19-acre Cronin tract, passing a 3/4" iron pipe set at 25.00 feet, for a total distance of 834.41 feet to a 3/4" iron pipe (Ahlers-Moe cap) found at the southeast corner of said 31.19-acre Cronin tract;

Thence, South 89 degrees 45 minutes 32 seconds West, along the south line of said 31.19-acre Cronin tract, passing a 3/4" iron pipe (Ahlers-Moe cap) found at 778.80, for a total distance of 870.75 feet to 3/4" iron pipe (Ahlers-Moe cap) found at the southwest corner of said 31.19-acre Cronin tract;

Thence, North 00 degrees 33 minutes 29 seconds East, passing a 3/4" iron pipe found (no cap) at 1457.88 feet, for a total distance of 1472.88 feet to the Point of Beginning.


