BEING A PART OF THE NORTHEAST QUARTER OF SECTION 9 AND A PART OF THE NORTHWEST QUARTER OF SECTION 10, TOWNSHIP 13, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, SALT CREEK TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING STONE AT THE NORTHWEST CORNER OF THE SAID NORTHEAST QUARTER OF SECTION NINE; THENCE SOUTH 89 DEGREES 32 MINUTES 38 SECONDS EAST 511.47 FEET ALONG THE NORTH LINE OF SAID NORTHEAST QUARTER TO A POINT IN BIG SALT CREEK, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE CONTINUING ALONG THE SAID NORTH LINE SOUTH 89 DEGREES 32 MINUTES 38 SECONDS EAST 2074.49 FEET TO A POINT IN THE CENTER OF TOWNSHIP ROAD NUMBER 106 (WOLF RUN ROAD), PASSING IRON PINS SET AT 213.74 FEET AND 2058.91 FEET; THENCE ALONG THE SAID CENTER OF TOWNSHIP ROAD NUMBER 106 THE NEXT 13 COURSES AND DISTANCES;

- 10) SOUTH 05 DEGREES 42 MINUTES 25 SECONDS EAST 127.39 FEET TO A POINT,
- 11) SOUTH 06 DEGREES 49 MINUTES 34 SECONDS EAST 76.31 FEET TO A POINT,
- 12) SOUTH 11 DEGREES 31 MINUTES 08 SECONDS EAST 158.73 FEET TO A POINT,

MINUTES 50 SECONDS WEST 1007.66 FEET ALONG THE SAID WEST LINE OF SECTION 10 TO AN IRON PIN SET, SAID IRON PIN SET BEING NORTH 00 DEGREES 45 MINUTES 50 SECONDS EAST 320.74 FEET FROM THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF SECTION 10; THENCE WITH THE MEANDERINGS OF BIG SALT CREEK AS DESCRIBED IN THE DEED CONVEYED TO L. K. AND D. S. DEAL RECORDED IN DEED BOOK VOLUME 699, PAGE 350 THE NEXT FIVE COURSES AND DISTANCES:

- 1) NORTH 38 DEGREES 29 MINUTES 59 SECONDS WEST 1693.69 FEET TO A POINT, PASSING AN IRON PIN SET AT 571.11 FEET,
- 2) NORTH 11 DEGREES 29 MINUTES 59 SECONDS WEST 281.47 FEET TO A POINT, SAID POINT BEING SOUTH 44 DEGREES 33 MINUTES 56 SECONDS WEST 27.25 FEET FROM AN IRON PIN SET,
- 3) SOUTH 78 DEGREES 30 MINUTES 01 SECONDS WEST 258.59 FEET TO A POINT,
- 4) NORTH 30 DEGREES 59 MINUTES 59 SECONDS WEST 457.51 FEET TO A POINT,
- 5) NORTH 45 DEGREES 59 MINUTES 59 SECONDS WEST 630.67 FEET TO THE PLACE OF BEGINNING.

CONTAINING 62.055 MORE OR LESS ACRES (TOTAL), 8.849 MORE OR LESS ACRES IN SECTION 10 AND 53.206 MORE OR LESS ACRES IN SECTION 9. SUBJECT TO ALL LEGAL ROAD RIGHT-OF-WAY OF TOWNSHIP ROAD NUMBER 106, AND ALL OTHER APPLICABLE EASEMENTS.

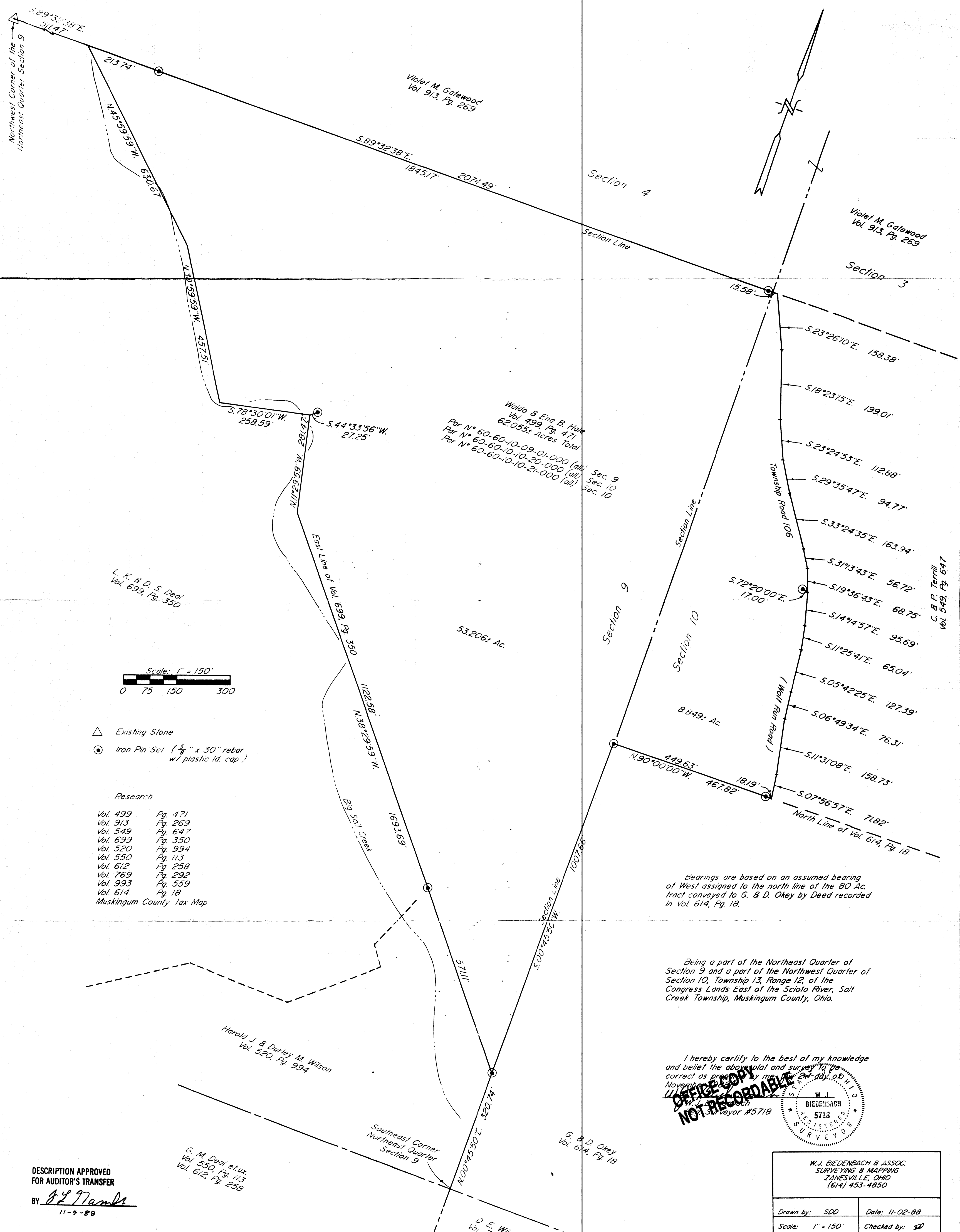

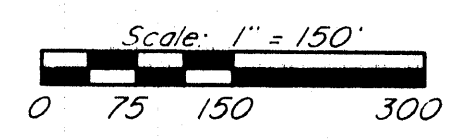
