

DESCRIPTION OF SURVEY FOR GARY L & CAROL S PROUTY JOB#1552

Situated in the State of Ohio, County of Muskingum, Township of Salt Creek;

Being part of the Southeast Quarter, of Section #10, Township #13, Range #12, of the Congress Lands East of the Scioto River, **being all of** Parcels #2 and #3 of the Gary L & and Carol S Prouty property recorded in Deed Book Volume 642, Page 197 of said county's deed records, further being known as all of Muskingum County Auditor's **Parcel Number 60-20-02-57-000**, and more particularly described as follows;

Beginning at an iron pin (set) at the Southwest corner of Lot #50 of Timberlake Addition #3 recorded in Plat Book 13, Page 82, being on the common line for Sections #10 and #15 of said Township and Range;

- #1- **THENCE North 88 degrees 00 minutes 05 seconds West 382.99 feet** along said Section line to an iron pin (found) on the East line of Palmer Drive (Township Road #699);
- #2- **THENCE North 03 degrees 00 minutes 25 seconds East 40.00 feet** into said Section #10, and along said Palmer Drive, and line of said Prouty property to an iron pin (found) at the Southwest corner of the David E and Rose A Curry property recorded in Deed Book Volume 542, Page 837;
- #3- **THENCE South 88 degrees 00 minutes 05 seconds East 185.00 feet** leaving said road, paralleling said Section line and along said properties to an iron pin (set);
- #4- **THENCE North 02 degrees 58 minutes 20 seconds East 199.50 feet** continuing along said properties to an iron pin (found) at a common corner for said Prouty and Curry properties and for the Allen W Moore and Jessica L Hayes property recorded in Official Record Volume 2065, Page 307;
- #5- **THENCE North 03 degrees 02 minutes 10 seconds East 120.00 feet** along said Prouty and Moore properties to an iron pin (found) at the common corner for said properties and for the Warren W Jr. and Shirley J Lent property recorded in Deed Book Volume 842, Page 305;
- #6- **THENCE South 87 degrees 59 minutes 00 seconds East 237.86 feet** along the common line for said Prouty and Lent properties to an iron pipe (found) at the a common corner for said properties, also being on the West line of said Timberlake Addition #3;
- #7- **THENCE South 09 degrees 18 minutes 45 seconds West 362.31 feet** along the common line for said Prouty property and Timberlake Addition #3 to the place of beginning, **containing 1.97 acres**, passing an iron pin (found) at 322.23 feet;

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

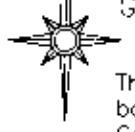
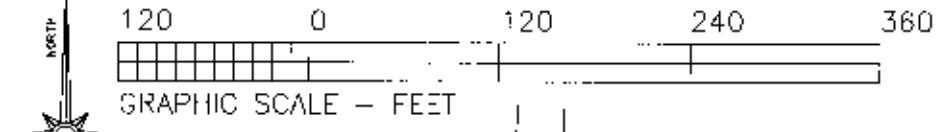

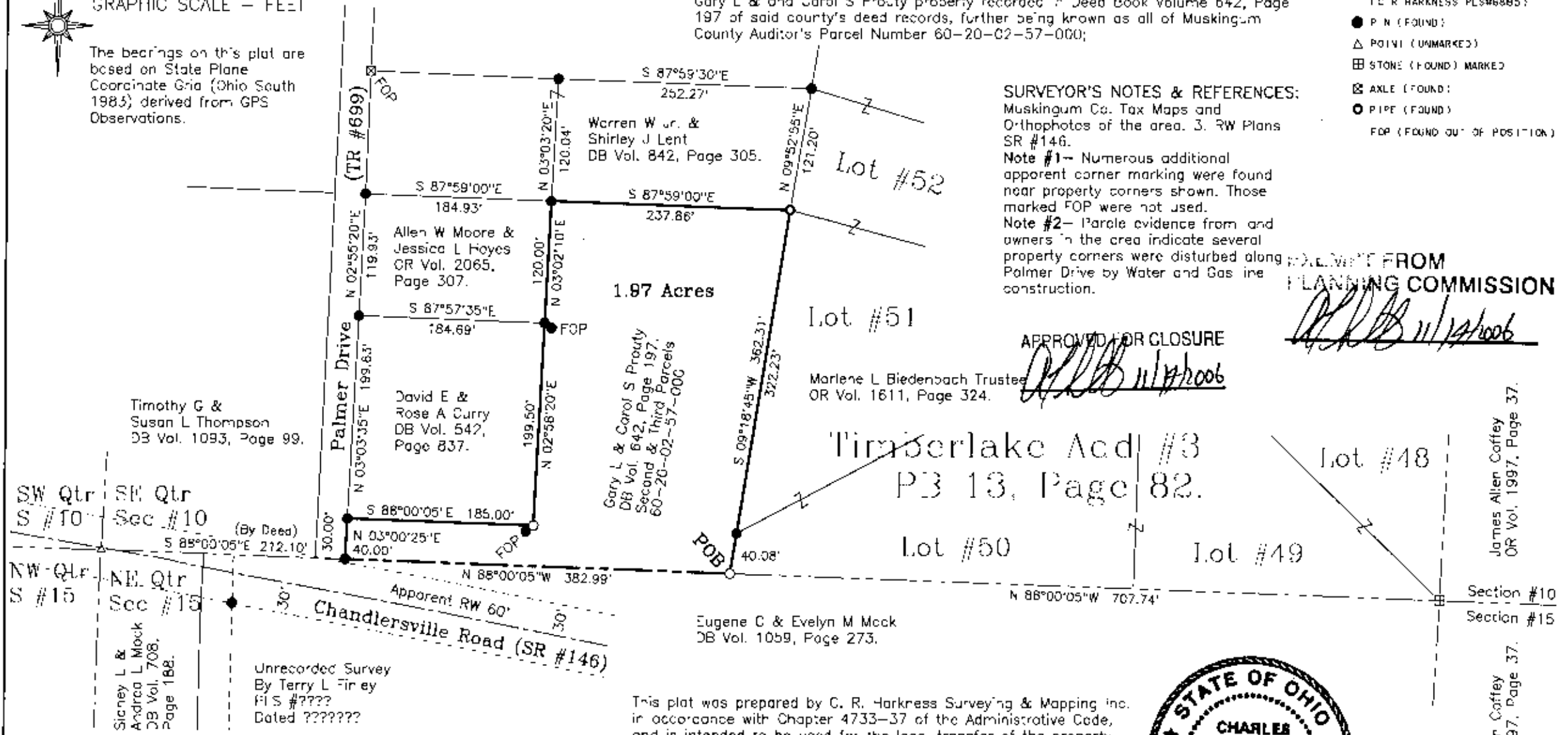
