

Survey for P. & M. Moore

Being a part of land located in the State of Ohio, County of Muskingum, Township of Salt Creek, in the southwest quarter of Section 2, Township 13 North, Range 12 West, bounded and described as follows:

TRACT#1:

Commencing at an iron pin found at the center of Section 2, Township 13 North, Range 12 West;

thence along the north line of the southwest quarter of Section 2 North 87 degrees 41 minutes 53 seconds West 269.29 feet to an iron pin found;

thence continuing along the north line of the southwest quarter of Section 2 North 87 degrees 41 minutes 53 seconds West 443.12 feet to an iron pin set;

thence continuing along the north line of the southwest quarter of Section 2 North 87 degrees 41 minutes 53 seconds West 98.83 feet to an iron pin set;

thence leaving the north line of the southwest quarter of Section 2 South 02 degrees 05 minutes 59 seconds West 19.57 feet to an iron pipe found, the place of beginning for tract 1;

thence South 02 degrees 05 minutes 59 seconds West 698.83 feet to an iron pin found;

thence continuing South 02 degrees 05 minutes 59 seconds West 22.05 feet to a point in the centerline of Clay Pike (CR 22);

thence along the centerline of Clay Pike (CR 22) on a curve to the left having a radius of 2045.75 feet and a delta of 11 degrees 20 minutes 25 seconds, a chord bearing and distance of South 88 degrees 28 minutes 59 seconds West 404.24 feet;

thence continuing along the centerline of Clay Pike (CR 22) North 85 degrees 51 minutes 00 seconds West 94.15 feet;

thence leaving the centerline of Clay Pike (CR 22) North 01 degrees 53 minutes 40 seconds East 22.18 feet to an iron pipe found;

thence continuing North 01 degrees 53 minutes 40 seconds East 737.00 feet to an iron pin found;

thence South 86 degrees 03 minutes 02 seconds East 500.50 feet to the place of beginning for tract 1, containing 8.46 acres, more or less.

TRACT#2:

Commencing at an iron pin found at the center of Section 2, Township 13 North, Range 12 West;

thence along the north line of the southwest quarter of Section 2 North 87 degrees 41 minutes 53 seconds West 269.29 feet to an iron pin found;

thence continuing along the north line of the southwest quarter of Section 2 North 87 degrees 41 minutes 53 seconds West 443.12 feet to an iron pin set;

thence continuing along the north line of the southwest quarter of Section 2 North 87 degrees 41 minutes 53 seconds West 98.83 feet to an iron pin set, the place of beginning for tract 2;

thence South 02 degrees 05 minutes 59 seconds West 19.57 feet to an iron pipe found;

thence North 86 degrees 03 minutes 02 seconds West 500.50 feet to an iron pin found;

thence North 01 degrees 53 minutes 40 seconds East 5.18 feet to an iron pin set on the north line of the southwest quarter of Section 2;

thence along the north line of the southwest quarter of Section 2 South 87 degrees 41 minutes 53 seconds East 500.27 feet to the place of beginning for tract 2, containing 0.14 acres, more or less.

Part of Parcel No.: 60-60-30-02-08-000 (\pm 0.14 acres)

This survey was performed at the request of the Muskingum County Engineer (Loren Camp) and was based upon a field survey by Muskingum County Technical Support Department and data supplied by Linn Engineering. This survey resolved the property line dispute over the north line of the southwest and southeast quarter of Section 2, Township 13 North, Range 12 West.

Iron pins set are 5/8 inch rebar 30 inches long with identification caps (DAVIS 7972). This legal description was based on a field survey made in May 2002 by Muskingum County Technical Support. The bearings in this description are based on NAD 83, Ohio South Zone, State Plane Coordinates as per GPS observations from Muskingum County GPS monument 11.

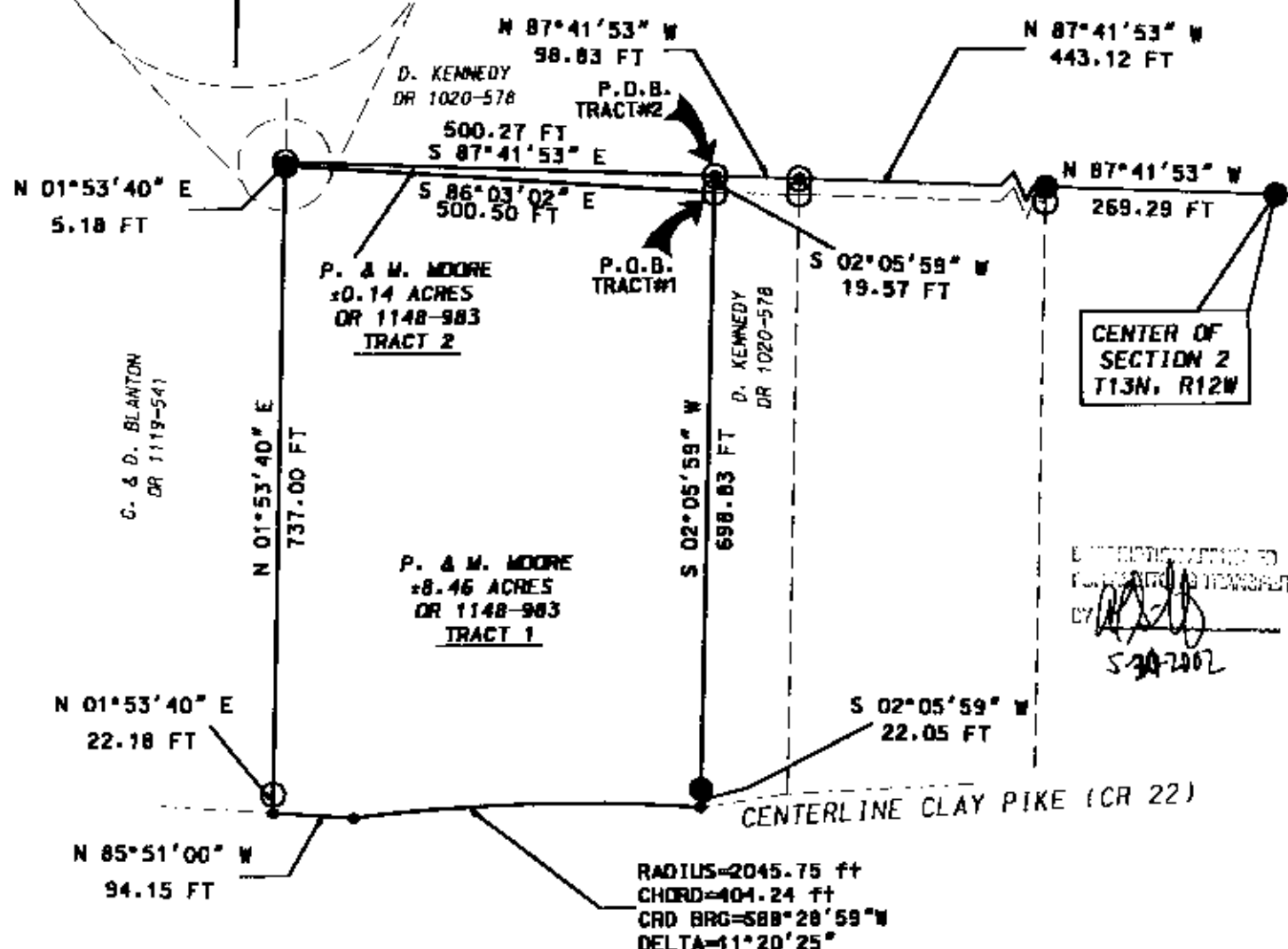
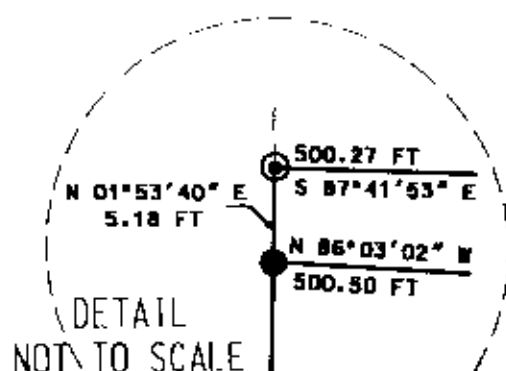

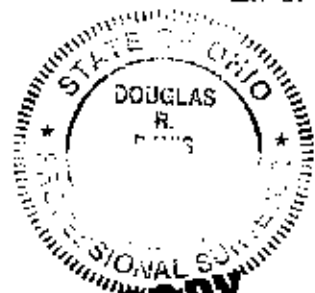
