DESCRIPTION OF SURVEY FOR SAMUEL THOMAS BLISS      JOB#1651-1

Situated in the State of Ohio, County of Muskingum, Township of Salt Creek:

Being part of the Southeast and Southwest Quarters, of Section #12, Township #13, Range #12, of the Congress Lands East of the Scioto River, **being all of the First and Third Parcels of the Samuel Thomas & Emma Juanita Bliss property recorded in Deed Book Volume 513, Page 499 of said county's deed records, further being known as Muskingum County Auditor's Parcel Numbers 60-30-12-07-000 and 60-30-12-10-000**, and more particularly described as follows;

- Beginning at a stone (found) at the Center of Section #12;
- #1- **THENCE South 87 degrees 20 minutes 50 seconds East 868.72 feet** along the common line for the Northeast and Southeast Quarters of Section #12 to an unmarked point in the centerline of Green Valley Road (County Road #83), passing an iron pin (set) at 843.72 feet;
  - #2- **THENCE along a curve to the left having, a chord bearing South 22 degrees 00 minutes 20 seconds West 172.94 feet**, a radius of 1026.58 feet, and arc length of 173.15 feet, into said Southeast Quarter, and along said road as described in the adjoining deed Keith N & Donna L Herron Official Record Volume 1549, Page 291 to an unmarked point;
  - #3- **THENCE along a curve to the right having, a chord bearing South 44 degrees 40 minutes 15 seconds West 388.26 feet**, a radius of 622.00 feet, and arc length of 394.85 feet continuing along said road by deed to an unmarked point;
  - #4- **THENCE South 62 degrees 51 minutes 20 seconds West 100.98 feet** continuing along said road by deed to an unmarked point;
  - #5- **THENCE along a curve to the left having, a chord bearing South 56 degrees 20 minutes 15 seconds West 304.27 feet**, a radius of 860.77 feet, and arc length of 305.88 feet, continuing along said road by deed to an unmarked point;
  - #6- **THENCE South 49 degrees 19 minutes 45 seconds West 288.66 feet** continuing along said road by deed to an unmarked point on the common line for said Southeast and Southwest Quarters of Section #12, from which an iron pin for reference bears South 02 degrees 05 minutes 05 seconds West 25.00 feet;
  - #7- **THENCE South 55 degrees 04 minutes 25 seconds West 199.24 feet** into said Southwest Quarter of Section #12 and continuing along said road as described in the adjoining deed William R & Martha Jean Adkins Deed Book Volume 583, Page 947 to an unmarked point;
  - #8- **THENCE South 72 degrees 25 minutes 55 seconds West 383.93 feet** continuing along said road by deed to an unmarked point;
  - #9- **THENCE South 57 degrees 19 minutes 25 seconds West 104.42 feet** continuing along said road by said deed and by the adjoining deed Jody Pyle Deed Book Volume 1155, Page 271 to an unmarked point;

- #10- **THENCE South 34 degrees 17 minutes 20 seconds West 343.21 feet** continuing along said road by said Pyle deed to an iron pin (found) in the roadbed of said road, at a common corner for said Samuel Bliss and Jody Pyle properties, also for the Robert H & Joy L Bliss property recorded in Deed Book Volume 528, Page 451;
- #11- **THENCE North 42 degrees 19 minutes 15 seconds West 234.25 feet** leaving said road and along a common line for said Bliss properties to an iron pipe (found), passing an iron pin (set) at 30.00 feet;
- #12- **THENCE North 89 degrees 35 minutes 25 seconds West 1678.66 feet** continuing along said Bliss properties to an unmarked point on the common line for Sections #12 and #11 of said Township and Range, being on the roadbed of Pine Lake Road (County Road #105), passing iron pins (found) at 1069.83 feet and 1666.54 feet
- #13- **THENCE North 02 degrees 20 minutes 15 seconds East 1367.25 feet** along said Section line to an iron pin (set replacing an iron pin found disturbed) at the common corner for the Southwest and Northwest Quarters of Section #12, and for the Southeast and Northeast Quarters of Section #11, passing an iron pin (set) at 607.23 feet, and leaving said roadbed at approximately 500 feet;
- #14- **THENCE South 87 degrees 46 minutes 30 seconds East 2625.18 feet** along the common line for the Southwest and Northwest Quarters of Section #12 to the place of beginning, containing 10.20 acres in the Southeast Quarter and 76.98 acres in the Southwest Quarter for a **total of 87.18 acres**, of which 1.05 acres are within the right of way for Green Valley Road (County Road #83) and 0.22 acres are within the right of way for Pine Lake Road (County Road #105).

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

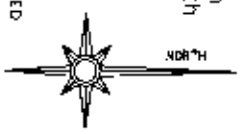

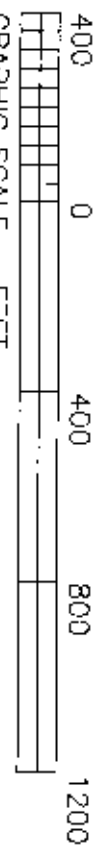
