Coffey & James A. Coffey (OR 2295-384);

thence with said mid section line, N 87°46'01" W, 882.93 feet to the point of beginning, passing an iron pin set at 160.03 feet, containing a total of 32.500 acres more or less, subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.

The above described 32.500 acre parcel is based on a field survey made by McPeck Land Surveying on April 5th, 2016.

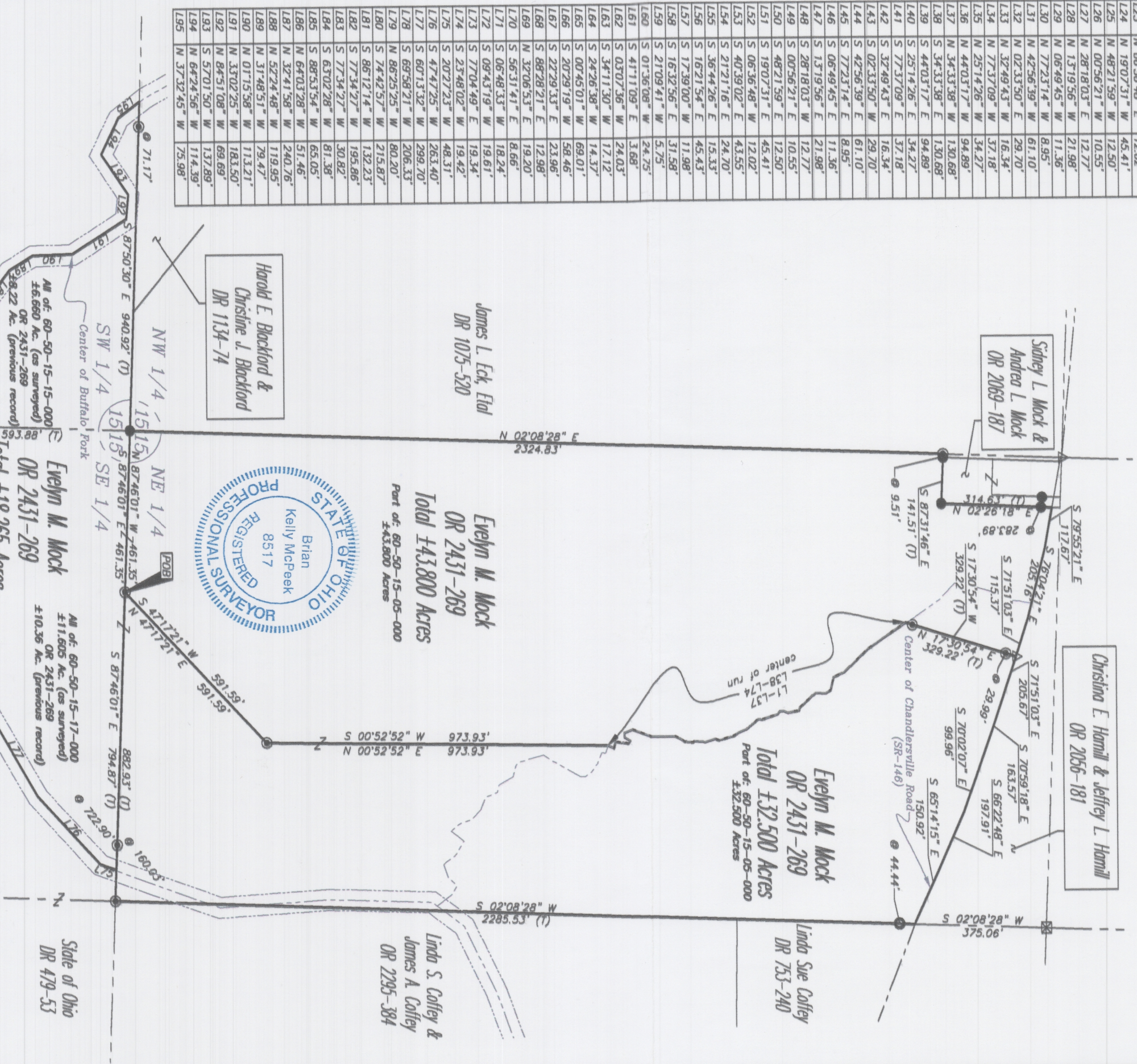

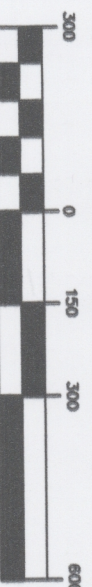
