COMMENCING AT THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF SECTION 28, THENCE, SOUTH OS DEGREES - OO MINUTES - OO SECONDS WEST, 2199.28 FEET TO A POINT; THENCE, NORTH 85 DEGREES - OO MINUTES - OO SECONDS WEST, 1320.00 FEET TO A POINT IN THE CENTER OF COUNTY ROAD 97 (SUGARGROVE ROAD), AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING ALONG SAID ROAD, NORTH 03 DEGREES - 21 MINUTES - 00 SECONDS WEST, 532.38 FEET TO A POINT; THENCE, NORTH 80 DEGREES - 42 MINUTES - 00 SECONDS WEST, 97.40 FEET TO A POINT AT THE INTERSECTION OF SAID COUNTY ROAD 97 AND TOWNSHIP ROAD 384 (MANNSFORK ROAD); THENCE, CONTINUING ALONG THE CENTERLINE OF SAID TOWNSHIP ROAD, NORTH 53 DEGREES - 48 MINUTES - 00 SECONDS WEST, 275.72 FEET TO A POINT; THENCE, NORTH 65 DEGREES - 30 MINUTES - 00 SECONDS WEST, 16.46 FEET TO A POINT; THENCE, LEAVING SAID TOWNSHIP ROAD, NORTH 80 DEGREES - 52 MINUTES - 49 SECONDS EAST, 646.09 FEET TO AN IRON PIN SET, PASSING AN IRON PIN FOUND AT 22.41 FEET; THENCE, NORTH 62 DEGREES - 58 MINUTES - 33 SECONDS EAST, 84.00 FEET TO AN IRON PIN SET IN THE CENTERLINE OF A 20 FOOT EASEMENT: THENCE, NORTH 45 DEGREES - 47 MINUTES - 55 SECONDS EAST, 69.79 FEET TO AN IRON PIN SET; THENCE, NORTH 77 DEGREES - 42 MINUTES - 06 SECONDS EAST, 143.75 FEET TO A POINT, PASSING AN IRON PIN SET AT 143.21 FEET; THENCE, SOUTH 05 DEGREES - 00 MINUTES - 00 SECONDS WEST, 468.69 FEET TO THE POINT OF BEGINNING, PASSING AN IRON PIN SET AT 443.69 FEET, AND CONTAINING 5.289 ACRES MORE OR LESS.

ALSO TO BE INCLUDED IN THE ABOVE-DESCRIBED PROPERTY IS A 20 FOOT WIDE INGRESS/EGRESS EASEMENT, THE CENTERLINE OF WHICH BEING FURTHER DESCRIBED AS FOLLOWS: COMMENCING AT A POINT IN THE CENTERLINE OF SUGARGROVE ROAD, WHICH BEARS NORTH 83 DEGREES - 21 MINTUES - 00 SECONDS WEST, 197.60 FEET FROM THE SOUTHEAST CORNER OF ABOVE-DESCRIBED 5.289 ACRE TRACT; THENCE, NORTH 11 DEGREES - 05 MINUTES - 56 SECONDS EAST, 284.78 FEET TO A POINT; THENCE, NORTH 07 DEGREES - 50 MINUTES - 05 SECONDS EAST, 29.53 FEET TO A POINT; THENCE, NORTH 02 DEGREES - 25 MINUTES - 42 SECONDS WEST, 33.09 FEET TO A POINT; THENCE, NORTH 25 DEGREES - 11 MINUTES - 36 SECONDS WEST, 25.39 FEET TO AN IRON PIN FOUND, AND THE TERMINUS OF THIS EASEMENT.
