MOCK (DEED VOLUME 1059, PAGE 276), SITUATED IN THE SOUTHEAST QUARTER OF SECTION 28, TOWNSHIP 13, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, SALT CREEK TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING STONE AT THE NORTHEAST CORNER OF THE SAID SOUTHEAST QUARTER OF SECTION 28;

THENCE WITH THE EAST LINE OF THE SAID SOUTHEAST QUARTER, SOUTH 00 DEGREES 00 MINUTES 00 SECONDS WEST 998.22 FEET TO A POINT, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH THE SAID EAST LINE, SOUTH 00 DEGREES 00 MINUTES 00 SECONDS WEST 349.22 FEET TO A POINT, SAID POINT BEING NORTH 00 DEGREES 00 MINUTES 00 SECONDS EAST 1278.06 FEET FROM AN EXISTING CONCRETE MONUMENT AT THE SOUTHEAST CORNER OF THE ABOVE SAID SOUTHEAST QUARTER;

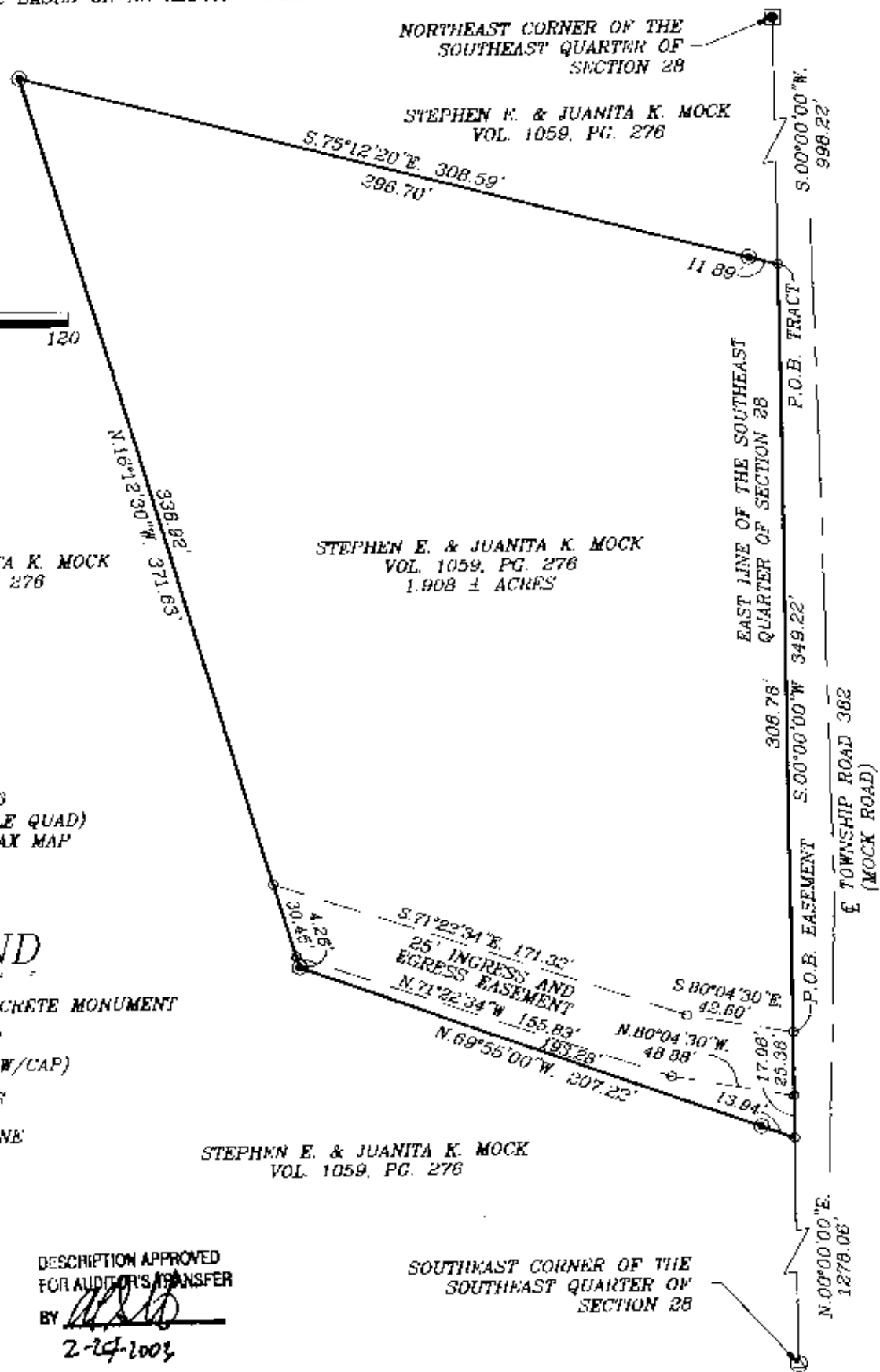
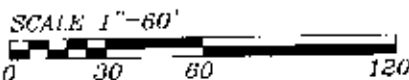
