DESCRIPTION OF SURVEY FOR EUGENE & EVELYN MOCK JOB#1365-1

- #3- THENCE South 88 degrees 26 minutes 50 seconds West 652.26 feet into the West Half of said Southwest Quarter and along a common line for said E & E Mock and Kemp properties to a stone (found marked) on the Mid Line for said West Half of the Southwest Quarter being a common corner for said E & E Mock and Kemp properties and for the T Lewis property recorded in Official Record Volume 1697, Page 425 and for the D Delaney property recorded in Deed Book Volume 1142, Page 527, passing a stone (found marked) at 11.41 feet;

- **#5-** THENCE North 87 degrees 20 minutes 30 seconds West 116.85 feet along the common line for said Northwest and Southwest Quarters of Section #28 to an iron pin (set) on the West bank of Manns Fork Salt Creek as called for in a deed to George Mason recorded in Deed Book Volume 397, Page 449;
- #6- THENCE North 10 degrees 32 minutes 10 seconds East 194.94 feet into said Northwest Quarter of Section #28 and along the said West bank and Mason deed to an iron pin (set);
- #7- THENCE North 46 degrees 28 minutes 25 seconds East 260.60 feet continuing along said creek bank and Mason deed to an iron pin (set) 56.50 feet from the Southwest corner of a stone abutment for the old bridge crossing said creek;

- #8- THENCE North 48 degrees 16 minutes 30 seconds West 112.00 feet continuing along said Mason deed and leaving said creek bank to the unmarked intersection of Sugargrove Road (County Road #97) (Previously called Old County Road) with Mannsfork Road (Township Road #384) (previously called New County Road);

- #12- THENCE South 01 degrees 16 minutes 20 seconds West 606.64 feet leaving said road and along a common line for said E & E Mock and Williams/Bates properties and crossing into said West Half of the Southwest Quarter of Section #28, to an iron pin (found), passing an iron pin (found) at 19.54 feet;
- **#13-** THENCE South 87 degrees 51 minutes 15 seconds East 207.28 feet along a common line for said E & E Mock and Williams/Bates properties crossing into to said East Half of the Southwest Quarter to an iron pin (found);
- #14- THENCE North 27 degrees 55 minutes 10 seconds East 661.75 feet along a common line for said E & E Mock and Williams/Bates properties crossing into the Northwest Quarter of Section #28 to an iron pin (found);
- **#15-** THENCE North 00 degrees 39 minutes 05 seconds East 26.79 feet along a common line for said E & E Mock and Williams/Bates properties to an unmarked point in the centerline of said Sugargrove Road;
- #16- THENCE North 88 degrees 39 minutes 40 seconds East 195.00 feet along said road to a magnetic reading;
- #17- THENCE North 75 degrees 23 minutes 25 seconds East 92.11 feet continuing along said road to a magnetic reading;
- **#18-** THENCE North 63 degrees 13 minutes 40 seconds East 21.10 feet continuing along said road to an unmarked corner of the G Mock property recorded in Official Record Volume 1701, Page 227;
- #19- THENCE South 04 degrees 55 minutes 30 seconds East 573.54 feet leaving said road and along a common line for said E & E Mock and G Mock properties and crossing into the Southwest Quarter of Section #28, to an iron pin (found), passing an iron pin (found) at 30.37 feet;
- **#20-** THENCE South 22 degrees 06 minutes 55 seconds East 310.04 feet leaving said road and along a common line for said E & E Mock and G Mock properties to an iron pin (found);
- **#21-** THENCE North 85 degrees 05 minutes 00 seconds East 160.59 feet along a common line for said E & E Mock and G Mock properties to an iron pin (found);

- **#22-** THENCE North 02 degrees 34 minutes 00 seconds West 1025.03 feat along a common line for said E & E Mock and G Mock properties and crossing into the Northwest Quarter of Section #28, to an unmarked point in the center line of said Sugargrove Road, passing iron pins (found) at 53.20 feet and at 999.99 feet;
- #23- THENCE North 55 degrees 23 minutes 10 seconds East 178.37 feet along the centerline of said road to a magnetic reading;
- #24- THENCE North 66 degrees 58 minutes 20 seconds East 153.33 feet continuing along said road to a magnetic reading;
- #25- THENCE North 83 degrees 10 minutes 50 seconds East 139.02 feet continuing along said road to an unmarked point on the common line for the Northwest and Northeast Quarters of Section #28;
- **#26-** THENCE South 02 degrees 07 minutes 40 seconds West 892.76 feet leaving said road and along said mid section line to the unmarked Center of Section #28, passing an iron pin (set) at 28.03 feet, for reference of the Center of Section an iron pin (set) on the common line for said Northwest and Southwest Quarters of Section #28 bears North 87 degrees 20 minutes 30 seconds West 123.54 feet;
- **#27-** THENCE South 02 degrees 20 minutes 40 seconds West 2623.80 feet along the common line for the Southeast and Southwest Quarters of Section #28 to the place of beginning, containing 17.22 acres in the Northwest Quarter and 101.12 acres in the Southwest Quarter for a total of **118.34 acres**.

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
