DESCRIPTION FOR CONVEYANCE

BEING A PART OF THE SOUTHEAST QUARTER OF SECTION 32, TOWNSHIP 13, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, WAYNE TOWNSHIP, AND ALSO A PART OF THE SOUTHWEST QUARTER OF SECTION 33, SALT CREEK TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT AT THE SOUTHEAST CORNER OF THE SOUTHEAST QUARTER OF SECTION 32 OF WAYNE TOWNSHIP; THENCE ALONG THE SOUTH LINE OF SAID SECTION 32 SOUTH 88 DEGREES 26 MINUTES 43 SECONDS WEST 80.00 FEET TO A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR), SAID POINT BEING NORTH 88 DEGREES 26 MINUTES 43 SECONDS EAST 240.00 FEET FROM A POINT MARKED BY AN EXISTING CONCRETE MONUMENT; THENCE NORTH 05 DEGREES 33 MINUTES 17 SECONDS WEST 217.00 FEET TO A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR); THENCE SOUTH 88 DEGREES 26 MINUTES 43 SECONDS WEST 385.00 FEET TO A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR); THENCE SOUTH 33 DEGREES 37 MINUTES 14 SECONDS EAST 132.45 FEET TO A POINT IN THE CENTERLINE OF TOWNSHIP ROAD 234 (POVERTY RIDGE ROAD); THENCE FOLLOWING THE SAID CENTERLINE OF TOWNSHIP ROAD 234 (POVERTY RIDGE ROAD) THE NEXT 4 COURSES AND DISTANCES:

- 1) NORTH 48 DEGREES 34 MINUTES 24 SECONDS WEST 58.52 FEET TO A POINT;
- 2) NORTH 58 DEGREES 26 MINUTES 08 SECONDS WEST 52.09 FEET TO A POINT;
- 3) NORTH 68 DEGREES 16 MINUTES 49 SECONDS WEST 73.13 FEET TO A POINT;
- 4) NORTH 75 DEGREES 03 MINUTES 54 SECONDS WEST 60.27 FEET TO A POINT; THENCE LEAVING SAID TOWNSHIP ROAD 234 NORTH 80 DEGREES 26 MINUTES 18 SECONDS EAST 1140.83 FEET TO A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR), PASSING A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR) AT 139.42 FEET; THENCE NORTH 32 DEGREES 02 MINUTES 36 SECONDS EAST 214.08 FEET TO A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR); THENCE SOUTH 89 DEGREES 22 MINUTES 47 SECONDS EAST 673.36 FEET TO A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR); THENCE SOUTH 01 DEGREE 53 MINUTES 30 SECONDS EAST 530.27 FEET TO A POINT MARKED BY AN EXISTING CONCRETE MONUMENT, SAID POINT BEING ON THE SOUTH LINE OF SECTION 33 OF SALT CREEK TOWNSHIP; THENCE ALONG THE SOUTH LINE OF SECTION 33 OF SALT CREEK TOWNSHIP SOUTH 88 DEGREES 26 MINUTES 43 SECONDS WEST 1302.95 FEET TO THE PLACE OF BEGINNING.

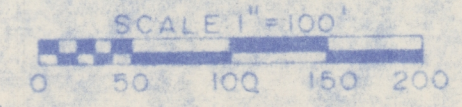
