Wilkins Volume 567, page 729, 846.39 feet to an iron pin set passing an iron pin set at 63.82 feet; Thence along Randy and Teresa Harman Volume 1100, page 21, South $89^{\circ}27'25''$ East 1009.29 feet to an iron pin set; Thence along the split lines of Nancy Apperson Volume 1538, page 6, the next two courses and distances – South $14^{\circ}30'44''$ West 623.65 feet to an iron pin set and South $31^{\circ}35'22''$ West 553.24 feet to an iron pin set on M. Ault's Line; Thence along M. Ault Volume 1734, page 13, the next two courses and distances – North $46^{\circ}19'35''$ West 178.17 feet to an iron pin found and North $75^{\circ}19'35''$ West 454.69 feet to a point to the place of beginning passing an iron pin found at 266.78 feet containing 18.75 Acres more or less.
