DESCRIPTION OF SURVEY FOR SUGARGROVE METHODIST CHURCH JOB#1588

Situated in the State of Ohio, County of Muskingum, Township of Salt Creek:

Being part of the Southeast and Southwest Quarters, of Section #35, of Township #13, Range #12, of the Congress Lands East of the Scioto River, **being all** of the Methodist Episcopal Church property recorded in Deed Book Volume "K", Page 254 of said county's deed records, further being known as Muskingum County Auditor's Parcel Number 60-90-35-15-000, and more particularly described as follows;


Commencing at a stone (found) marked at the center of said Section #35;

- TIE-1 THENCE North 68 degrees 20 minutes 40 seconds West 213.90 feet along the common line for the Northwest and Southwest Quarters if said Section #35 to an unmarked point in the centerline of Sugargrove Road (County Road #97), passing an iron pin (found) at 198.90 feet;
- TIE-2 THENCE South 00 degrees 28 minutes 55 seconds West 254.69 feet into said Southwest Quarter and along said road as surveyed by William H Derwacter PLS #5437 dated June 19, 1989 to an unmarked common corner for said Church property and for the Marjorie E Massey property recorded in Deed Book Volume 537, Page 476, also being the place of beginning for the property herein intended to be described;
- #1- THENCE South 88 degrees 20 minutes 40 seconds East 330.00 feet leaving said road and along said Church and Massey properties and crossing into said Southeast Quarter of Section #35, to an iron pin (set), passing an iron pin (set) at 20.00 feet;
- #2- THENCE South 01 degrees 39 minutes 20 seconds West of 198.00 feet continuing along said Church and Massey properties to an iron pin (set) at a common corner for the Sait Creek Township Trustees property recorded in Deed Book Volume 301, Page 116;
- **#3-** THENCE North 88 degrees 20 minutes 40 seconds West 248.11 feet along the common line for said Church and Township properties crossing into said Southwest Quarter of Section #35, to a unmarked point in the centerline of said road, passing an iron pin (set) at 218.11 feet;
- #4- THENCE North 43 degrees 19 minutes 30 seconds West 27.48 feet continuing along said road by said Derwacter Survey to an unmarked point;
- #5- THENCE North 37 degrees 58 minutes 00 seconds West 54.53 feet continuing along said road by said Derwacter Survey to an unmarked point;
- #6- THENCE North 20 degrees 52 minutes 00 seconds West 50.60 feet continuing along said road by said Derwacter Survey to an unmarked point;
- #7- THENCE North 06 degrees 34 minutes 35 seconds West 52.68 feet continuing along said road by said Derwacter Survey to an unmarked point;
- #6- THENCE North 00 degrees 28 minutes 55 seconds East 37.69 feet continuing along said road by said Derwacter Survey to the place of beginning, containing 1.40 acres, of which 0.10 acres are within the right of way for Sugargrove Road (County Road #97).

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
