Commencing at an iron pin found at the Northwest Corner of the Southwest Quarter of Section 10; Thence South $00^{\circ}15'22''$ West 1166.76 feet to a point; Thence South $89^{\circ}44'38''$ East 421.16 feet to a point in center of access road the place of beginning; Thence on a 300 foot radius curve to the left the chord of which bears North $86^{\circ}00'41''$ East 76.76 feet to a point in center of said access road; Thence continuing along said road North $78^{\circ}43'14''$ East 188.07 feet to a point; Thence North $69^{\circ}48'27''$ East 472.64 feet to an iron pin set; Thence South $00^{\circ}06'40''$ West along G&J Wilson Vol. 997, Page 362 and D. Collins Vol. 999, Page 442, 430.00 feet to an iron pin found; Thence South $89^{\circ}52'25''$ West along Wanda L. Harris Vol. 859, Page 161, 703.22 feet to an iron pin set; Thence North $00^{\circ}08'21''$ West along the split line of C.G. Mahan 226.28 feet to the place of beginning passing an iron pin set at 206.28 feet containing 5.00 acres more or less:

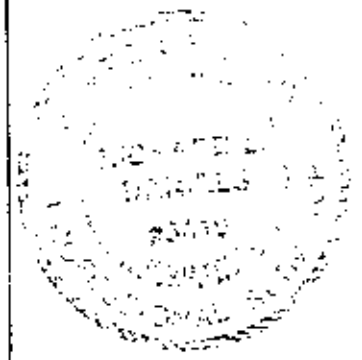

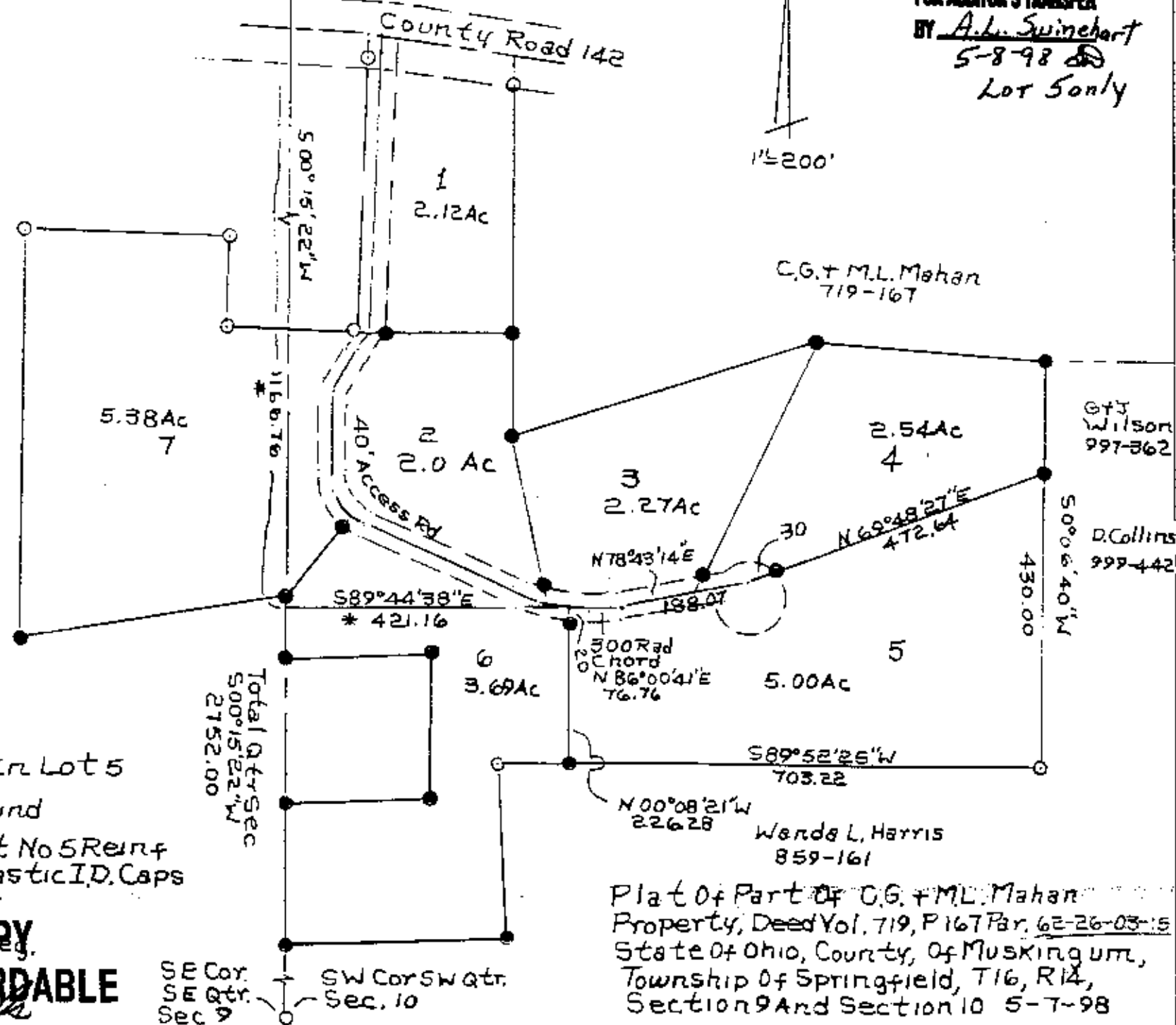
