**ALL OF AUDITORS PARCEL
62-31-03-72-000 (0.442 Acres)**

Situated in the S.E. $\frac{1}{4}$, Section 11, T-16,, R-14, Springfield Township, Muskingum County, Ohio. Being the remaining lands of Alice Guttery recorded in Deed book 817 page 332 of the Muskingum County Deed Records and being described as follows:

Commencing at the Southwest corner of the Southeast quarter of Section 11; thence, S.84°57'53"E. a distance of 30.00 feet along the South line of said Quarter Section to a point on the East line of Potts Lane; thence, N.23°49'15"E. a distance of 206.63 feet along the said lane to a point, BEING THE POINT OF BEGINNING;

Thence, N.23°49'15"E. a distance of 136.46 feet along said lane to a point on the Southwest corner of the lands, now or formerly, owned by S. Layton (1136/109);

Thence, S.75°03'20"E. a distance of 122.45 feet along the South line of said Layton lands to a found iron pin, passing a found iron pin at 7.63 feet;

Thence, S.16°52'10"W. a distance of 158.80 feet along the West line of Said Layton lands to a found iron pin on the North line of the lands, now or formerly, owned by J. Wilson (1140/220);

Thence, N.65°14'50"W. a distance of 140.10 feet along the North line of said Wilson lands to the point of beginning, passing a found iron pin at 135.70 feet.

The above described parcel contains 0.442 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

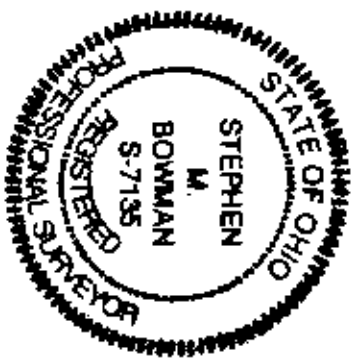

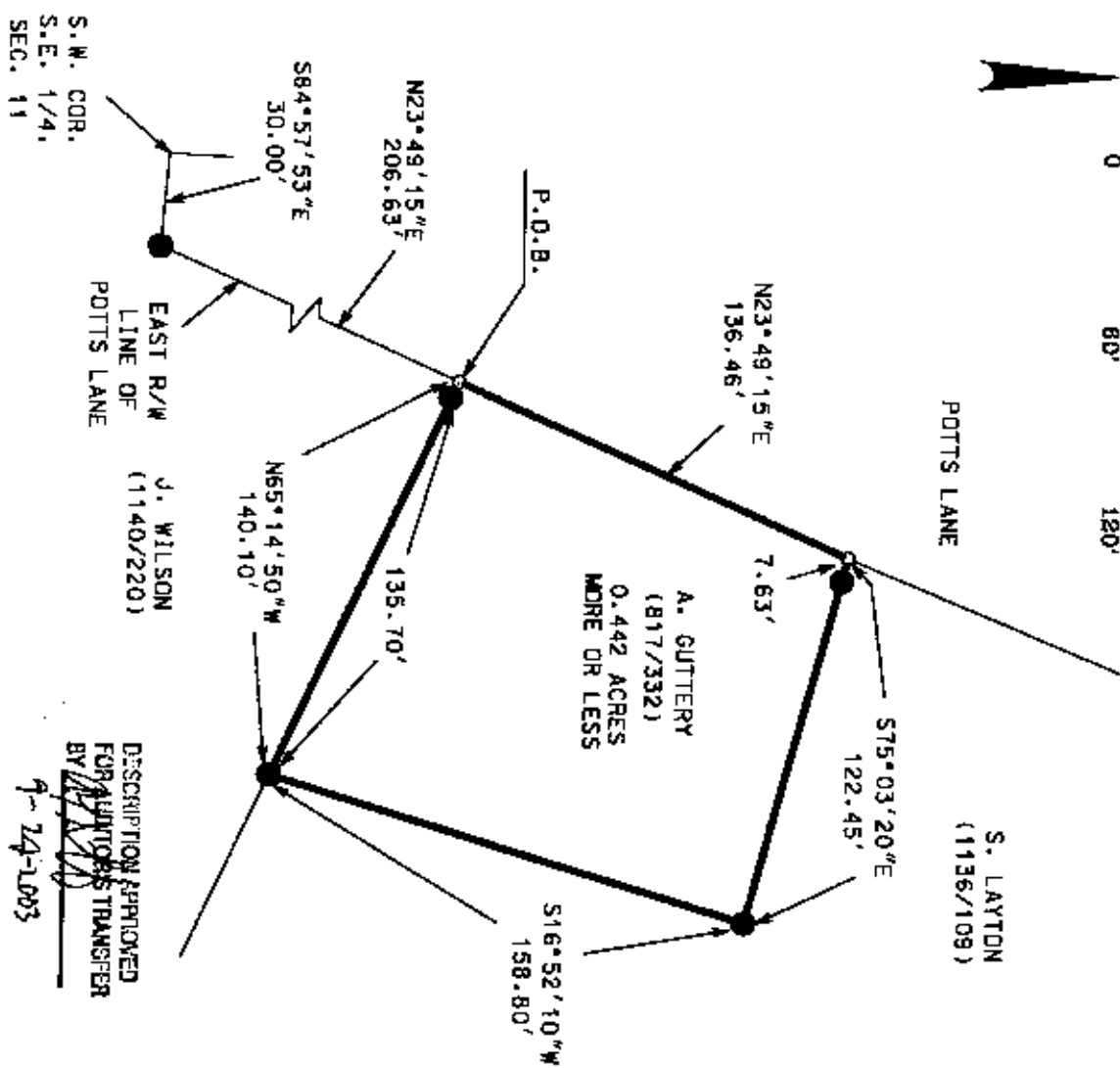
