

DESCRIPTION OF SURVEY FOR MEADOW FARM CHURCH

Situated in the State of Ohio, County of Muskingum, Township of Springfield,

Being part of the Northeast Quarter, of Section #18, Township #16, Range #14, of the Congress Lands East of the Scioto River, being part of the prior deed reference Volume 512, Page 919, of said county's deed records, also being part of Muskingum County Auditor's Parcel Number 62-62-36-01-03-000, and more particularly described as follows;

Commencing at a stone (found) at the Southeast Corner, of the Northeast Quarter, of Section #18; thence N 01 12 00 E 174.07 feet along the East line of Section #18, to a Railroad Spike (found) in the Center line of Coopermill Road (Co. Rd. #71), also being the place of beginning for the property herein intended to be described;

- #1- thence N 80 28 06 W 129.19 feet along said center line of said Coopermill Road as surveyed by L Peter Dinan RS #5451 as recorded in deed reference Volume 800, Page 140;
- #2- thence N 00 54 18 E 367.08 feet leaving said center line and through the prior deed reference Volume 512, Page 919, to an iron pin (set), passing an iron pin (set) at 21.45 feet;
- #3- thence S 84 17 29 E 130.12 feet continuing through said prior deed reference Volume 512, Page 919, to an iron pin (set) on the East line of said Section #18;
- #4- thence S 01 12 00 W 120.71 feet along said East line to an iron pin (set) at the Northeast corner of the Meadow Farm Church property;
- #5- thence N 88 48 00 W 79.86 feet along the North line of said church property to an iron pin (set) at a corner of said church property;
- #6- thence S 01 12 00 W 39.60 feet along a line of said church property, to an iron pin (set);
- #7- thence S 88 48 00 E 7.86 feet continuing along said church property, to an iron pin (set);
- #8- thence S 01 12 00 W 42.00 feet continuing along said church property, to an iron pin (set);
- #9- thence S 88 48 00 E 12.00 feet continuing along said church property, to an iron pin (set);
- #10- thence S 01 12 00 W 145.07 feet continuing along said church property, to an iron pin (set) on the North side of said Coopermill Road, at the Southwest corner of said church property;
- #11- thence S 81 15 21 E 60.52 feet, along the South line of said church property, to an iron pin (set) on the East line of said Section #18;
- #12- thence S 01 12 00 W 20.24 feet along the East line of said Section #18, to the place of beginning, containing 0.750 Acres.

The bearings within the description are based on the East line of Section #18, as surveyed by W.J. Biedenbach RS #5718, as described in deed reference Volume 838, Page 180. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).




