

DESCRIPTION OF SURVEY FOR COMMUNITY BANK, INC.

Situated in the State of Ohio, County of Muskingum, Township of Springfield:

Being part of the Northwest Quarter, of Section 17, Township 16, Range 14, of the Congress Lands East of the Scioto River, **being all of the Community Bank, Inc.** property recorded in Official Record Volume 2107, Page 32, Parcel One, of said county's deed records, further being all of Muskingum County **Auditor's Parcel Number 62-39-01-28-001**, and more particularly described as follows;

Commencing at an iron pipe (found) at the center of Section 17;

- TIE- THENCE North 03 degrees 11 minutes 05 seconds East 169.08 feet** along the common line for the Northwest and Northeast Quarters of Section 17 to an unmarked point in the centerline of Coopermill Road, being the place of beginning for the property herein intended to be described, passing an iron pin (found) at 143.95 feet;
- #1- THENCE North 73 degrees 16 minutes 40 seconds West 20.57 feet** into said Northwest Quarter and along said road to the unmarked Southeast corner of the Kenneth B Campbell and Phyllis Campbell property recorded in Deed Book Volume 999, Page 301;
- #2- THENCE North 03 degrees 11 minutes 05 seconds East 470.00 feet** leaving said road and along a common line for said Bank and Campbell properties to an iron pin (set), passing an iron pin (set) at 33.33 feet;
- #3- THENCE North 86 degrees 48 minutes 15 seconds West 677.54 feet** continuing along said Bank and Campbell properties to an iron pin (found) on the East line of the Keith Sealock and Deloris Sealock property recorded in Official Record Volume 1672, Page 680;
- #4- THENCE North 04 degrees 37 minutes 50 seconds East 609.32 feet** along said Bank and Sealock properties also along the Clata Otto Luburgh and Sally A Luburgh property recorded in Official Record Volume 2224, Page 546 to an iron pin (found) at the Southwest corner of Lot 16 of Wilkins Meadows Subdivision recorded in Plat Book 18, Page 107;
- #5- THENCE South 86 degrees 51 minutes 55 seconds East 682.16 feet** along said Bank property and Lot 16 to an unmarked point on the common line for said Northwest and Northeast Quarters of Section 17, from which an iron pin (found) for reference bears South 86 degrees 51 minutes 50 seconds East 0.94 feet;
- #6- THENCE South 03 degrees 11 minutes 05 seconds West 1084.67 feet** along said Quarter Section line to the place of beginning, passing iron pins (found) at 296.67 feet and 1044.83, **containing 9.87 acres.**

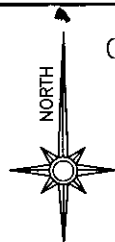
