Situated in the State of Ohio, County of Muskingum, Township of Springfield, Township 15, Range 14, part of the Northeast Quarter of Section 3, bounded and described as follows:

Commencing at a railroad spike found at the Southeast corner of the Northeast Quarter of Section 3 in Pinkerton Road (County Road 125); thence South $90^{\circ} 00' 00''$ West 1570.35 feet to a point; thence North $0^{\circ} 00' 00''$ East 202.75 feet to a point in County Road 125; thence North $55^{\circ} 49' 33''$ West 70.11 feet to a point in center of said road, the place of beginning; thence in center of County Road 125 North $57^{\circ} 04' 24''$ West 233.99 feet to a point; thence leaving said road North $13^{\circ} 47' 18''$ East along the remainder of Francis Sheppard, Vol. 355, Page 346, 407.65 feet to an iron pin set, passing an iron pin set at 21.00 feet; thence along Francis Sheppard North $78^{\circ} 56' 47''$ West 130.31 feet to an iron pin set; thence North $5^{\circ} 55' 34''$ East along Melvin McHenry, Vol. 813, Page 88, 373.63 feet to an iron pin found; thence South $80^{\circ} 12' 58''$ East along David Sheppard, Vol. 873, Page 80, 183.68 feet to an iron pin set; thence South $0^{\circ} 29' 34''$ East along Ruth Russell, Vol. 456, Page 587, and R. & M. Greiner, Vol. 572, Page 248, 888.51 feet to the place of beginning, passing iron pins at 636.90 feet and 860.37 feet, containing 3.350 acres more or less.

Bearings are based on the South line of the Northeast Quarter of Section 3 bearing South $90^{\circ} 00' 00''$ West.

Iron pins set are No. 5 reinforcing bars 30 inches long with plastic I. D. caps.

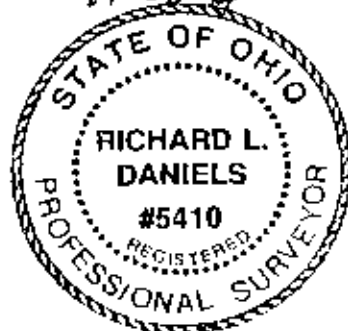

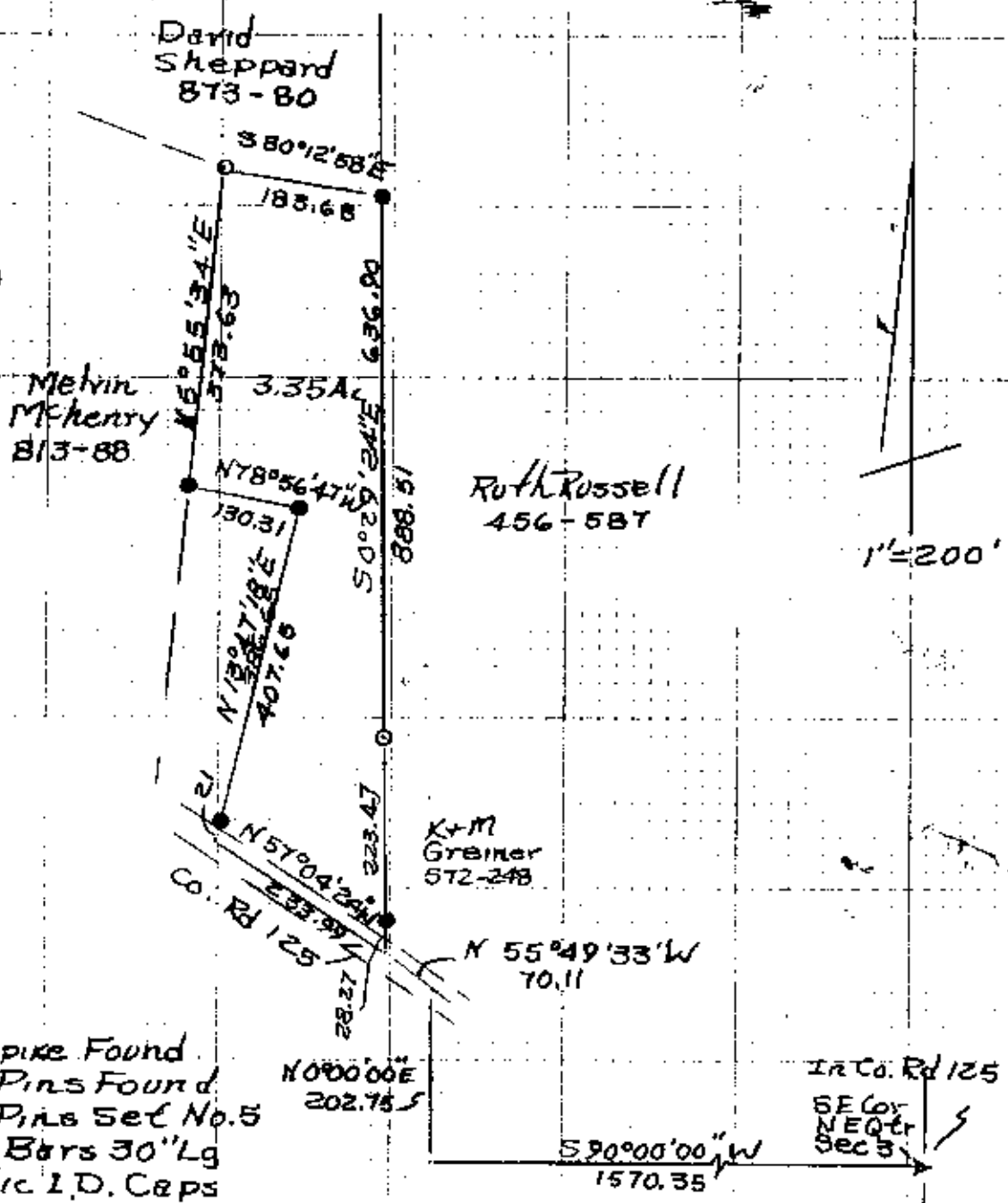
