LEGAL DESCRIPTION FOR LINDA GRAHAM

Situated in the State of Ohio, County of Muskingum, Township of Springfield, and being part of the northwest quarter of Section 2, Township 15, Range 14, and being all those lands intended to be described in Deed Volume 1675, page 518; being further bounded and described as follows:

Commencing at the northwest corner of Section 2, thence, south 87 degrees – 35 minutes – 00 seconds east, 815.90 feet along the north line of Section 2 to an iron pin found, and the *true point of beginning* for the parcel herein intended to be described;

Thence, south 88 degrees – 55 minutes – 23 seconds east, 396.27 feet to a point in County Road 143 (Potts Lane), passing an iron pin found at 340.48 feet;

Thence, along said road, the following four (4) courses and distances:

- 1) south 28 degrees – 26 minutes – 26 seconds west, 29.43 feet to a point;
- 2) south 32 degrees – 38 minutes – 49 seconds west, 37.46 feet to a point;
- 3) south 36 degrees – 42 minutes – 43 seconds west, 35.25 feet to a point;
- 4) south 39 degrees – 48 minutes – 48 seconds west, 95.09 feet to a point;

Thence, leaving said road, north 87 degrees – 35 minutes – 00 seconds west, 284.85 feet to an iron pin found, passing an iron pin set at 28.39 feet;

Thence, north 01 degrees – 42 minutes – 04 seconds east, 154.22 feet to the *point of beginning*, and containing 1.253 acres more or less.

SUBJECT to all legal highways and easements of record, whether recorded or implied.

Iron pins set are 5/8" rebar with yellow identification cap (Finley S-7222).

Bearings described herein are based upon assumed azimuth and to be used for angle purposes only.




