

**DESCRIPTION OF SURVEY FOR THOMAS J EDWARDS & VICKI EDWARDS

Situated in the State of Ohio, County of Muskingum, Township of Springfield:

Being part of Lot 4 of Maysville Country Place recorded in Plat Book 4, Page 128, further **being part of** the Thomas John Edwards DDS Trustee and Vicki L Edwards Trustee property recorded in **Official Record Volume 3182, Page 868**, and further **being part of** Muskingum County Auditor's Parcel Number 62-72-02-04-000, and more particularly described as follows;

Beginning at an axle found at the common Northern corner for Lots 4 and 5 of said Maysville Country Place;

- #1- **THENCE North 73 degrees 13 minutes 28 seconds East 65.98 feet** along the North line of Lot 4 and common line for said Edwards property and for the Richard H McClelland and Joyce Ann McClelland Trustees property recorded in Official Record Volume 2622, Page 783 to an iron pin (set) at the common corner for Lots 3 and 4 of said Maysville Country Place;
- #2- **THENCE South 16 degrees 53 minutes 32 seconds East 315.12 feet** along the common line for said Lots 3 and 4 and common line for said Edwards property and for a second Thomas John Edwards DDS Trustee and Vicki L Edwards Trustee property recorded in Official Record Volume 3182, Page 868, to an iron pin (set);
- #3- **THENCE South 73 degrees 09 minutes 34 seconds West 65.93 feet** crossing Lot 4 to an iron pin (set) on the common line for Lots 4 and 5;
- #4- **THENCE North 16 degrees 54 minutes 05 seconds West 315.20 feet** along the common line for Lots 4 and 5 and for said Edwards property and for the Donald R Stewart and Marjorie M Stewart Trustees property recorded in Deed Book Volume 1157, Page 733 to the place of beginning, **containing 0.477 acres.**

Parcel not to be used as a separate building site or transferred as an independent parcel in the future without planning commission approval in accordance with applicable subdivision regulations. Parcel to be combined with adjacent Auditor's Parcel Number 62-72-02-03-000.

The bearings and distances within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. See Plat for META Data. Iron pins (set) are 5/8" rebar 30 inches long with identification cap (C.R.Harkness P.L.S.6885).

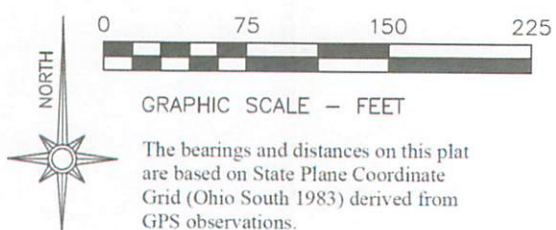

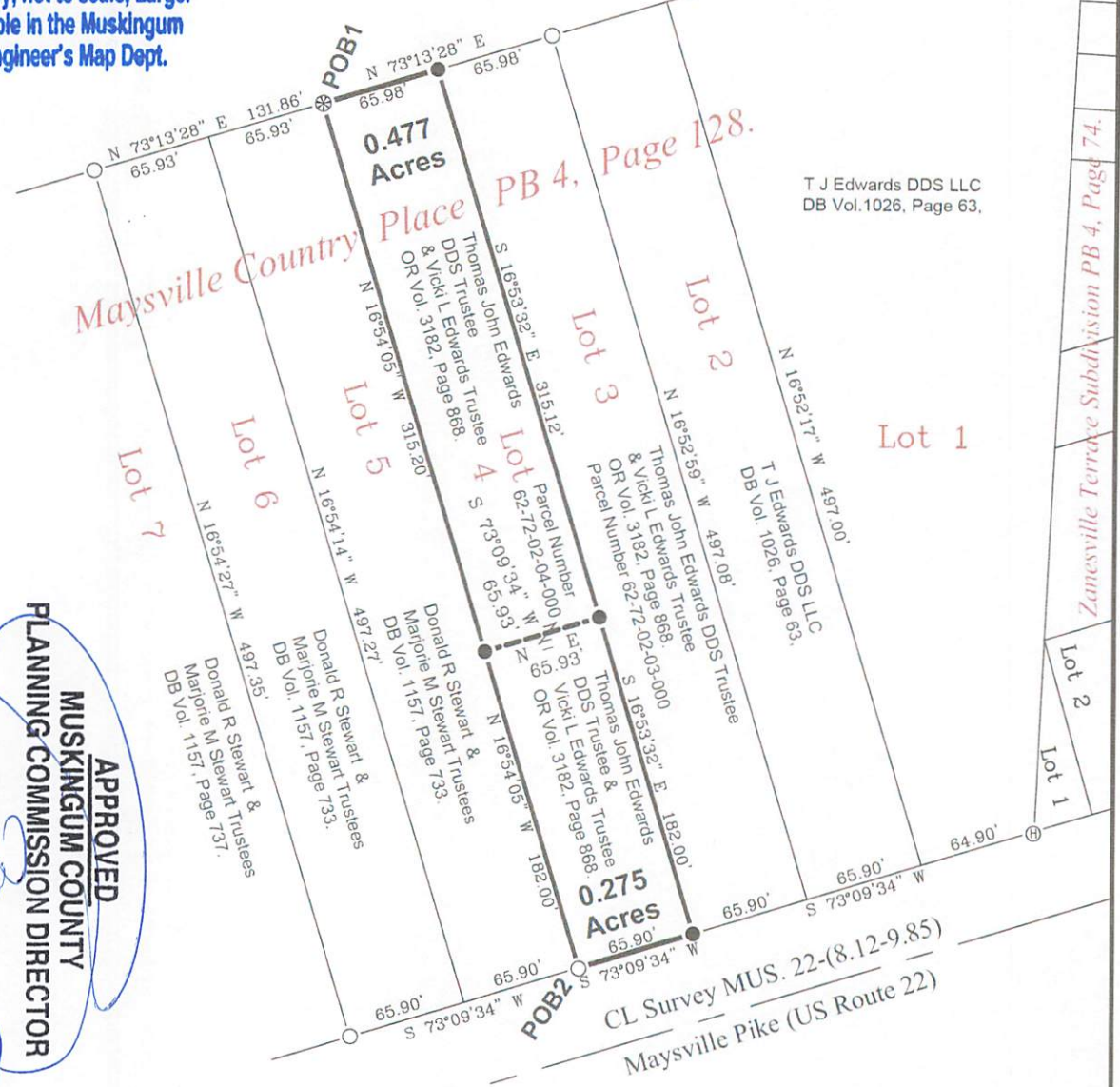
