

**Raymond Wilkes**

Situated in the State of Ohio, County of Muskingum, Springfield Twp., Township 15, Range 14, Section 2, bounded and described as follows:

Being part of Deed Vol. 1030, Page 17, Parcel No. 62-62-72-03-07-000.

Commencing at a stone found at the Southwest Corner of the Northeast Quarter of Section 2; Thence North  $5^{\circ}50'00''$  East 7.60 feet to an axle found; Thence South  $83^{\circ}29'00''$  East 664.45 feet in Greenhouse Road to a point; Thence in Greenhouse Road South  $83^{\circ}20'53''$  East 710.40 feet to a point; Thence leaving Greenhouse Road North  $14^{\circ}25'53''$  West 775.03 feet to an iron pin found on U.S. 22 Right of Way; Thence North  $75^{\circ}34'07''$  East along U.S. 22 Right of Way 699.08 feet to a point the place of beginning; Thence North  $75^{\circ}34'07''$  East along Rt. 22 66.68 feet to a point; Thence along the split line of Ray Wilkes South  $17^{\circ}06'47''$  East 190.17 feet to an iron pin set; Thence along Z Town Development Vol. 1137, Page 752 South  $75^{\circ}34'07''$  West 56.79 feet to an iron pin set passing an iron pin found at 7.36 feet; Thence along the split line of Raymond Wilkes North  $20^{\circ}04'48''$  West 190.88 feet to the place of beginning containing 0.269 acres more or less:

Bearings are based on the South line of the Northeast Quarter of Section 2 bearing South  $83^{\circ}40'29''$  East.

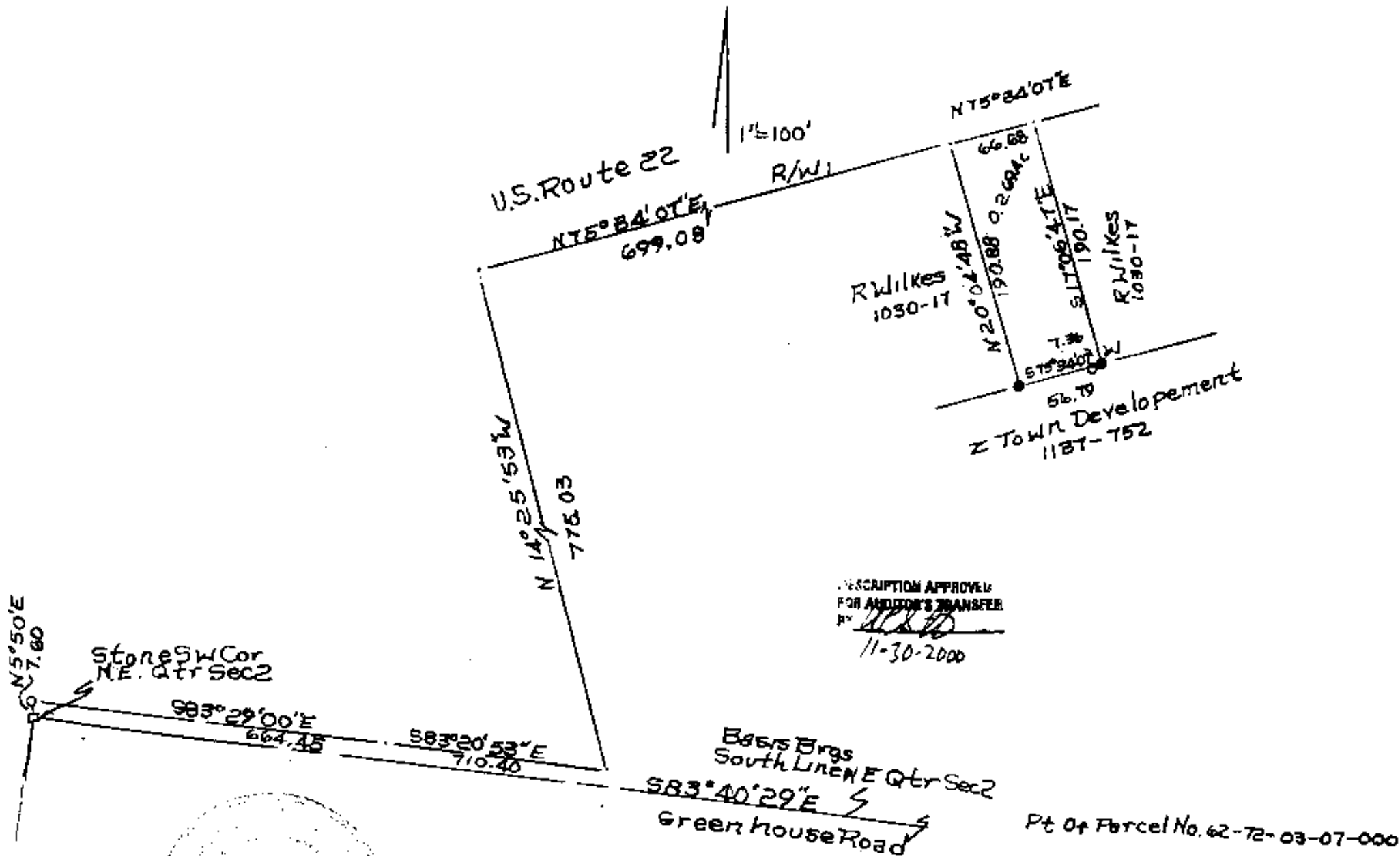
Iron pins set are No. 5 reinf. bars 30 inches long with plastic ID caps.
