DESCRIPTION OF 1.076 ACRES VILLAGE OF SOUTH ZANESVILLE MUSKINGUM COUNTY, OHIO

Situate in the Village of South Zanesville, County of Muskingum, State of Ohio, being part of the lands of Burley Clay Products, more particularly described as follows:

Beginning at a 5/8" iron pin with Bowman cap found at the intersection of the north right-of-way line of relocated East King Street and the east right-of-way line of Maysville Avenue, said point also being the southwest corner of a 1.08 acre tract conveyed to Tim Donut U.S. Limited, Inc. in Deed Volume 1969, Page 434, thence along the east right-of-way line of Maysville Avenue, North 23° 09' 18" East a distance of 135.00 feet to a 5/8" iron pin set at the **True Point of Beginning**;

Thence continuing along the east right-of-way line of Maysville Avenue, North 23° 09' 18" East a distance of 145.00 feet to a 5/8" iron pin set;

Thence along a new division line through the lands of Burley Clay Products, South 66° 53' 44" East a distance of 309.58 feet to a 5/8" iron pin set on the west line of the railroad right-of-way;

There along the west of said railroad right-of-way, South 12° 26' 52" West a distance of 147.54 feet to a 5/8" iron pin with Bowman cap found at the northeast corner of said 1.08 acre tract;

Thence along the north line of said 1.08 acre tract, North 66° 53' 44" West a distance of 336.99 feet to the True Point of Beginning;

Containing 1.076 acres, more or less.

Subject to all legal highways, easements, and restrictions of record.

Basis of Bearings: east right-of-way line of Maysville Avenue
