DESCRIPTION OF SURVEY FOR THE BURLEY CLAY PRODUCTS CO.

Situated in the State of Ohio, County of Muskingum, Village of South Zanesville:

Being a part of the Pennel Company Railroad right of way formerly known as the Zanesville Terminal Railroad, also being a part of the property described in deed reference Volume 605, Page 159, also being all of the Muskingum County Auditor's Parcel Number 63-63-06-04-22-000, and more particularly described as follows;

Beginning at an iron pipe (found) at the Southwest corner of Lot #652, of South Zanesville, recorded in Plat Book 2, Page 96 of the plat records of said county, also being at the intersection of the North line of East Berkley Street as shown on the plat of South Zanesville and the East right of way line for said railroad; thence along the East right of way of said railroad S 24 02 47 W 340.00 feet to an iron pin (set) on the North right of way of East King Street as shown on the plat of South Zanesville, passing an iron pin (set) on the South line of East Berkley Street at 60.00 feet; thence along the North line of said East King Street N 66 00 51 W 60.00 feet to an iron pin (set) on the West right of way line of said railroad and on the East right of way line for US Route #22 ( Maysville Pike ); thence along the West line of said railroad and the East line of said US Route #22 N 24 02 47 E 340.00 feet to the North line of said East Berkley Street, passing an iron pin (set) on the South line of said East Berkley Street at 280.00 feet; thence along the North line of said East Berkley Street S 66 00 51 E 60.00 feet to the place of beginning containing 0.468 acres.

The bearings within this description are based on the South line of La Salle Street as described in deed reference Volume 930, Page 184. Iron pins (set) are 3/8" rebar with aluminum identification caps.

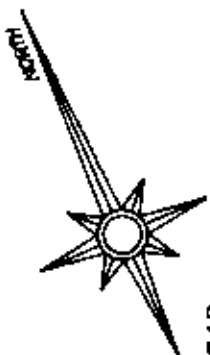

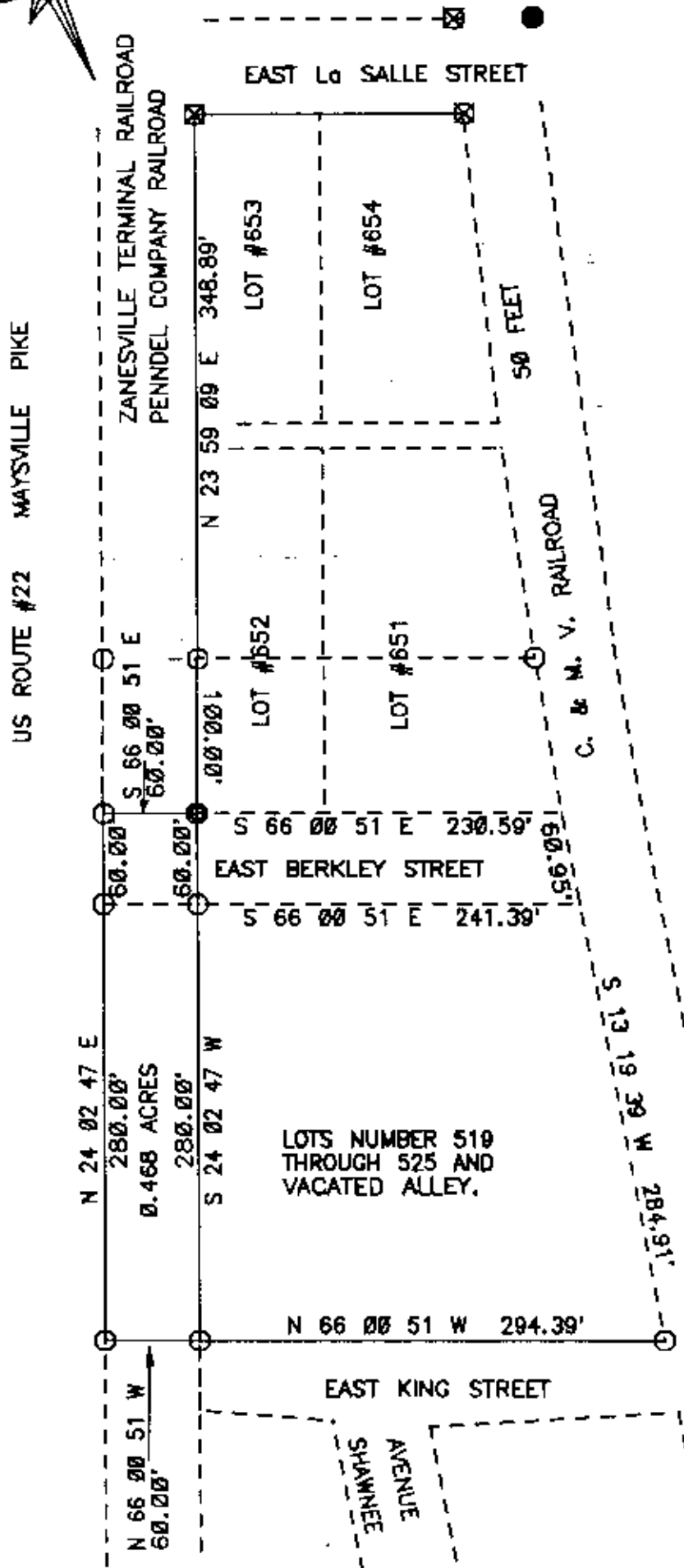
