COMMENCING AT A EXISTING IRON PIN (3/4 INCH REBAR) AT THE NORTHWEST CORNER OF THE NORTHWEST QUARTER OF SECTION 5;

THENCE WITH THE WEST LINE OF SAID SECTION SOUTH 03 DEGREES 42 MINUTES 18 SECONDS WEST 1409.30 FEET TO A POINT ON THE NORTHWEST CORNER OF A 104.38 MORE OR LESS ACRE TRACT CONVEYED TO WAYNE DAILEY IN DEED VOLUME 989, PAGE 384 OF THE MUSKINGUM COUNTY DEED RECORDS;

THENCE WITH THE SAID NORTH LINE SOUTH 86 DEGREES 25 MINUTES 50 SECONDS EAST 1447.94 FEET TO AN EXISTING RAILROAD SPIKE IN THE CENTER OF TOWNSHIP ROAD 440 (PIDCOCK ROAD);

THENCE CONTINUING WITH THE SAID TOWNSHIP ROAD 440 THE NEXT 8 COURSES AND DISTANCES;

- 1) SOUTH 61 DEGREES 30 MINUTES 18 SECONDS EAST 74.29 FEET TO AN EXISTING RAILROAD SPIKE;

- 5) CONTINUING SOUTH 67 DEGREES 20 MINUTES 44 SECONDS EAST 51.11 FEET TO A POINT;
- 6) SOUTH 64 DEGREES 39 MINUTES 50 SECONDS EAST 148.54 FEET TO A POINT;
- 7) SOUTH 59 DEGREES 27 MINUTES 51 SECONDS EAST 73.86 FEET TO A POINT;
- 8) SOUTH 52 DEGREES 08 MINUTES 36 SECONDS EAST 4.49 FEET TO A POINT; SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

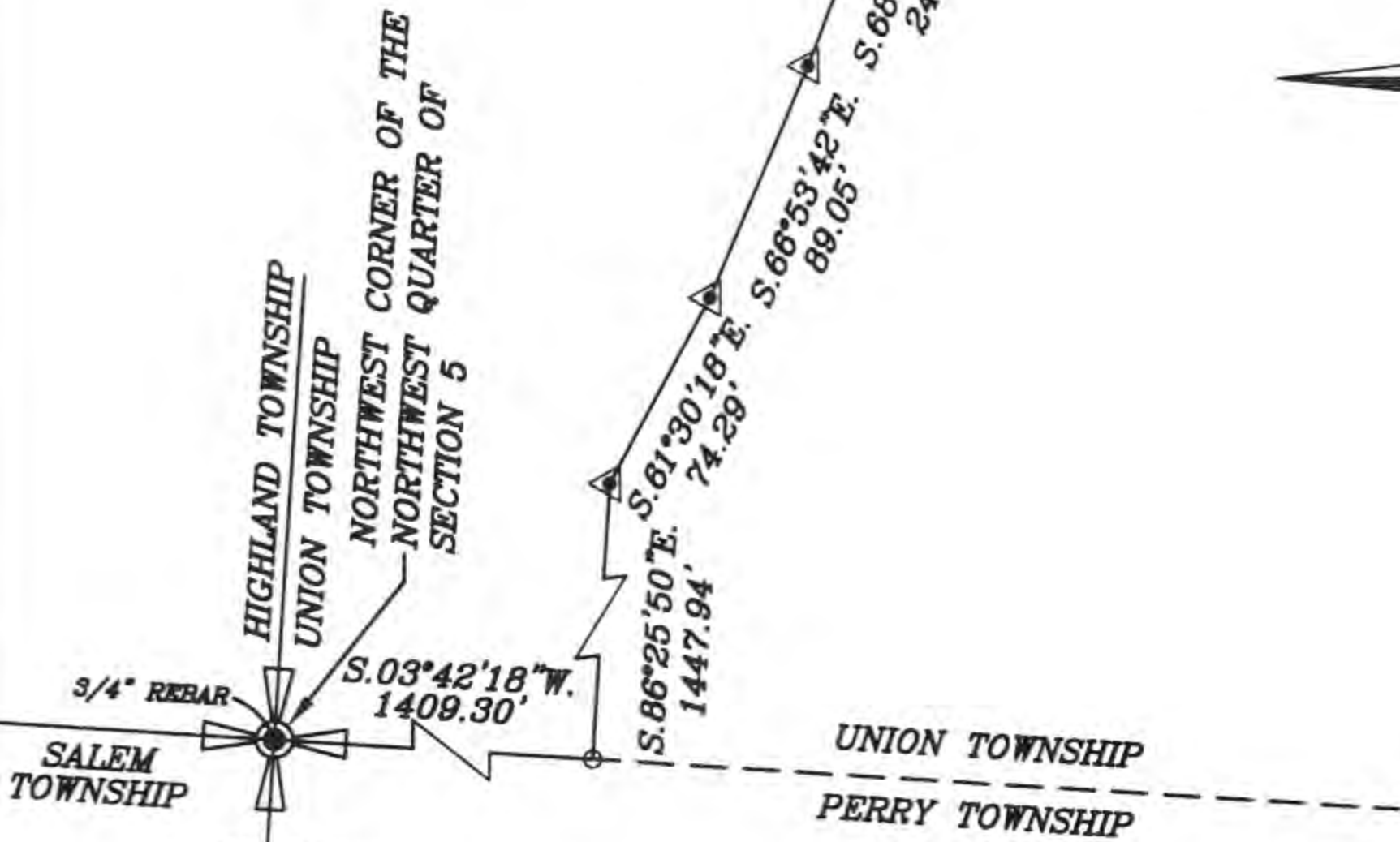
