Situated in Union Township, Muskingum County, Ohio and being 1.871 acres more or less in the Southwest Quarter of Section # 4, Township # 1 North, Range # 5 West in the United States Military Lands Survey and being more particularly described as follows: Commencing at a stone found at the Northwest corner of the Southwest Quarter of Section # 4, Thence S 84° 54' 00" E a distance of 667.86 feet to an iron pin found, Thence S 05° 15' 08" W a distance of 1522.30 feet to a railroad spike found, the **BEGINNING**, Thence with the center of Pidcock Road and the lands of now or formerly Clarence Tyson as found in Volume 542 Page 945 S 73° 03' 59" E a distance of 81.28 feet to a railroad spike found, Thence with the lands of now or formerly M. & J. Richards as found in Volume 1138 Page 477 S 00° 48' 08" E a distance of 373.37 feet to an iron pin found (having passed through an iron pin found at 30.00 feet), Thence with a new division line through the lands of now or formerly William Graham as found in Volume 522 Page 286 the following two (2) calls:

1. N 85° 35' 05" W a distance of 50.07 feet to an iron pin set.
2.
