Rd. No. 692; thence with the center of said road south 79 degrees 12 minutes 20 seconds west 85.85 feet to a point; thence leaving said road south 16 degrees 48 minutes 40 seconds east 148.47 feet to a point on the north right of line of U. S. Rt. 40; thence with said line south 54 degrees 08 minutes 05 seconds west 455.97 feet to an iron pin, said pin being the true place of beginning for the tract herein to be described; thence continuing south 54 degrees 08 minutes 05 seconds west 268.03 feet to an iron pin; thence south 49 degrees 22 minutes 05 seconds west 269.60 feet to an iron pin; thence leaving said line north 18 degrees 49 minutes 42 seconds west 109.84 feet to an iron pin; thence north 5 degrees 50 minutes 15 seconds east 131.89 feet to an iron pin; thence north 14 degrees 02 minutes 15 seconds east 120.90 feet to an iron pin; thence north 24 degrees 47 minutes 15 seconds east 43.62 feet to an iron pin; thence north 32 degrees 35 minutes 45 seconds east 80.94 feet to an iron pin; thence north 18 degrees 12 minutes 35 seconds east 64.24 feet to an iron pin; thence south 84 degrees 25 minutes 20 seconds east 295.60 feet to an iron pin; thence south 13 degrees 33 minutes 20 seconds east 163.97 feet to the place of beginning containing 3.119 acres more or less.


